AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF HIGHER EDUCATION AND THE DEPARTMENT OF HIGHER EDUCATION; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER EDUCATION AND THE DEPARTMENT OF HIGHER EDUCATION; REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - HENDERSON STATE UNIVERSITY. There is hereby appropriated, to the Henderson State University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Henderson State University the following:

(A) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 1 of Act 445 of 2011, for equipment, personal services, maintenance and operating expenses, and grants of the Rural Entrepreneurial Initiative and for construction, acquisition, renovation, furnishing, personal services, maintenance and equipment, in a sum not to exceed\$2,000,000.

(B) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 7 of Act 709 of 2011, for Phase I campus renovations, in a sum not to exceed.....\$2,200,000.

(C) Effective July 1, 2012, the balance of the appropriation provided in Item (B) Section 7 of Act 709 of 2011, for local area network



infrastructure, in a sum not to exceed.....\$800,000.

(D) Effective July 1, 2012, the balance of the appropriation provided in Item (C) Section 7 of Act 709 of 2011, for deferred maintenance, in a sum not to exceed.....\$1,330,000.

(E) Effective July 1, 2012, the balance of the appropriation provided in Item (D) Section 7 of Act 709 of 2011, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$620,000.

SECTION 2. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY. There is hereby appropriated, to the Southern Arkansas University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Southern Arkansas University the following:

(A) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 8 of Act 709 of 2011, for construction of a University Agriculture Center, in a sum not to exceed.....\$1,100,000.

(B) Effective July 1, 2012, the balance of the appropriation provided in Item (B) Section 8 of Act 709 of 2011, for technology upgrades, in a sum not to exceed.....\$1,000,000.

(C) Effective July 1, 2012, the balance of the appropriation provided in Item (C) Section 8 of Act 709 of 2011, for renovation of the Bruce Center, in a sum not to exceed.....\$400,000.

(D) Effective July 1, 2012, the balance of the appropriation provided in Item (D) Section 8 of Act 709 of 2011, for deferred maintenance, in a sum not to exceed.....\$1,410,000.

(E) Effective July 1, 2012, the balance of the appropriation provided in Item (E) Section 8 of Act 709 of 2011, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$510,000.

(F) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 2 of Act 766 of 2011, for construction of a University Agriculture Center, in a sum not to exceed.....\$1,000,000.

(G) Effective July 1, 2012, the balance of the appropriation provided in Item (D) Section 2 of Act 766 of 2011, for constructing, equipping, personal services, maintenance and operating expenses of a Natural Resources Research Center for research of lignite and other natural resources in the State, in a sum not to exceed.....\$75,000.

(H) Effective July 1, 2012, the balance of the appropriation provided

in Item (E) Section 2 of Act 766 of 2011, for construction/renovation/
maintenance/critical maintenance/equipment/library resources, in a sum not to
exceed.....\$100,000.

(I) Effective July 1, 2012, the balance of the appropriation provided
in Item (F) Section 2 of Act 766 of 2011, for expenses of a lignite
feasibility study, in a sum not to exceed.....\$32,194.

(J) Effective July 1, 2012, the balance of the appropriation provided
in Item (G) Section 2 of Act 766 of 2011, for critical maintenance/equipment
/library resources, in a sum not to exceed.....\$38,787.

SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - BEEBE. There
is hereby appropriated, to the Arkansas State University - Beebe, to be
payable from the General Improvement Fund or its successor fund or fund
accounts, for the Arkansas State University - Beebe the following:

(A) Effective July 1, 2012, the balance of the appropriation provided
in Item (A) Section 1 of Act 253 of 2011, for construction, renovations,
equipment, maintenance and operating expenses for an addition to the Latimer
Building of the ASU - Heber Springs campus for vocational or allied health
programs, in a sum not to exceed.....\$500,000.

(B) Effective July 1, 2012, the balance of the appropriation provided
in Item (A) Section 1 of Act 361 of 2011, for the ASU - Searcy main building
renovation, in a sum not to exceed.....\$1,000,000.

(C) Effective July 1, 2012, the balance of the appropriation provided
in Item (A) Section 2 of Act 361 of 2011, for lighting and mechanical system
upgrades at the ASU - Beebe campus, in a sum not to exceed.....\$500,000.

(D) Effective July 1, 2012, the balance of the appropriation provided
in Item (A) Section 3 of Act 709 of 2011, for renovation of the ASU-Searcy
Main Building, in a sum not to exceed.....\$1,000,000.

(E) Effective July 1, 2012, the balance of the appropriation provided
in Item (B) Section 3 of Act 709 of 2011, for energy conservation lighting
upgrades, in a sum not to exceed.....\$500,000.

(F) Effective July 1, 2012, the balance of the appropriation provided
in Item (C) Section 3 of Act 709 of 2011, for deferred maintenance, in a sum
not to exceed.....\$730,000.

(G) Effective July 1, 2012, the balance of the appropriation provided
in Item (D) Section 3 of Act 709 of 2011, for replacement and renewal of

equipment and library holdings, in a sum not to exceed.....\$500,000.

(H) Effective July 1, 2012, the balance of the appropriation provided in Item (D) Section 3 of Act 766 of 2011, for construction/renovation/maintenance/critical maintenance/equipment/library resources, in a sum not to exceed.....\$5,293.

SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - GENERAL IMPROVEMENT. There is hereby appropriated, to the Arkansas State University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University the following:

(A) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 1 of Act 252 of 2011, for construction, equipping, landscaping, personal services, operations, finishing, furnishing, and parking of a liberal arts building, in a sum not to exceed\$38,375,068.

(B) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 1 of Act 262 of 2011, for acquisition, reconstruction, remodeling, personal services and operating expenses of heritage sites, in a sum not to exceed.....\$1,800,000.

(C) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 1 of Act 482 of 2011, for acquisition, reconstruction, equipping, maintenance and operations of historic buildings in the Historic Dyess Colony/Boyhood Home of Johnny Cash Heritage Sites, in a sum not to exceed.....\$250,000.

(D) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 1 of Act 497 of 2011, for deferred maintenance for classrooms, buildings and related infrastructure, in a sum not to exceed\$7,000,000.

(F) Effective July 1, 2012, the balance of the appropriation provided in Item (C) Section 1 of Act 497 of 2011, for constructing, equipping, landscaping, parking lot, and other construction related costs of completing a liberal arts teaching building, in a sum not to exceed.....\$33,000,000.

(G) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 2 of Act 709 of 2011, for construction and replacement of Wilson Hall, in a sum not to exceed.....\$4,000,000.

(H) Effective July 1, 2012, the balance of the appropriation provided in Item (B) Section 2 of Act 709 of 2011, for deferred maintenance, in a sum not to exceed.....\$3,690,000.

(I) Effective July 1, 2012, the balance of the appropriation provided in Item (C) Section 2 of Act 709 of 2011, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$2,030,000.

SECTION 5. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - TRUST - DYESS COLONY/JOHNNY CASH TOWN CENTER RESTORATION. There is hereby appropriated, to the Arkansas State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas State University the following:

(A) Effective July 1, 2012, the balance of the appropriation provided in Section 30 of Act 692 of 2011, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or

objects, in a sum not to exceed.....\$262,000.

SECTION 6. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MOUNTAIN HOME.

There is hereby appropriated, to the Arkansas State University - Mountain Home, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University - Mountain Home the following:

(A) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 4 of Act 709 of 2011, for construction of the Vada Sheid Community Development Center, in a sum not to exceed.....\$780,000.

(B) Effective July 1, 2012, the balance of the appropriation provided in Item (B) Section 4 of Act 709 of 2011, for library renovation, in a sum not to exceed.....\$320,000.

(C) Effective July 1, 2012, the balance of the appropriation provided in Item (C) Section 4 of Act 709 of 2011, for deferred maintenance, in a sum not to exceed.....\$90,000.

(G) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 1 of Act 768 of 2011, for equipment and technology needs, in a sum not to exceed.....\$319,500.

SECTION 7. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - NEWPORT.

There is hereby appropriated, to the Arkansas State University - Newport, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University - Newport the following:

(A) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 5 of Act 709 of 2011, for renovation of technical laboratories at the Marked Tree campus, in a sum not to exceed\$1,150,000.

(B) Effective July 1, 2012, the balance of the appropriation provided in Item (B) Section 5 of Act 709 of 2011, for deferred maintenance, in a sum not to exceed.....\$210,000.

(C) Effective July 1, 2012, the balance of the appropriation provided in Item (C) Section 5 of Act 709 of 2011, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$210,000.

(A) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 1 of Act 654 of 2011, for maintenance and general operations, renovation, construction, personal services, equipment and operating expenses, in a sum not to exceed.....\$500,000.

(B) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 6 of Act 709 of 2011, for construction of an academic

classroom facility, in a sum not to exceed.....\$2,315,000.

(C) Effective July 1, 2012, the balance of the appropriation provided in Item (B) Section 6 of Act 709 of 2011, for renovation and critical maintenance of educational and general buildings, in a sum not to exceed\$935,000.

SECTION 23. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FORT SMITH. There is hereby appropriated, to the University of Arkansas - Fort Smith, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas - Fort Smith the following:

(A) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 1 of Act 680 of 2011, for personal services, operating expenses, maintenance, equipment, supplies, construction, and renovation, in a sum not to exceed.....\$1,000,000.

(B) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 10 of Act 709 of 2011, for the expansion and upgrade of the library, in a sum not to exceed.....\$2,750,000.

(C) Effective July 1, 2012, the balance of the appropriation provided in Item (B) Section 10 of Act 709 of 2011, for deferred maintenance, in a sum not to exceed.....\$1,150,000.

(D) Effective July 1, 2012, the balance of the appropriation provided in Item (C) Section 10 of Act 709 of 2011, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$870,000.

(E) Effective July 1, 2012, the balance of the appropriation provided in Item (D) Section 10 of Act 709 of 2011, for personal services, operating

expenses, and grants to support the continuation of the Arkansas Delta Training and Education Consortium University Center initiatives, in a sum not to exceed.....\$386,100.

(A) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 1 of Act 709 of 2011, for various maintenance, renovation, equipping, construction, acquisition, improvement, upgrade, and repair of real property and facilities for all public four-year institutions, two-year institutions, and technical colleges, in a sum not to exceed\$5,000,000.

(B) Effective July 1, 2012, the balance of the appropriation provided in Item (C) Section 20 of Act 766 of 2011, for grants for scholarships for Historically Black Colleges and Universities and for personal services and operating expenses as determined by the Department of Higher Education for outreach programs to promote awareness of the scholarships for Historically Black Colleges and Universities, in a sum not to exceed.....\$100,000.

SECTION 25. REAPPROPRIATION - DEPARTMENT OF HIGHER EDUCATION - TRUST - COLLEGE SAVINGS OBLIGATION. There is hereby appropriated, to the Department of Higher Education, to be payable from the Higher Education Projects Development Fund, for the Department of Higher Education the following:

(A) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 21 of Act 766 of 2011, for the development of projects at State Institutions of Higher Education and the payment of project costs and

expenses of the issuance of bonds of the Arkansas College Savings General Obligation Bonds Program, in a sum not to exceed.....\$122,628.

SECTION 26. REAPPROPRIATION - DEPARTMENT OF HIGHER EDUCATION - TRUST - COLLEGE SAVINGS BOND. There is hereby appropriated, to the Department of Higher Education, to be payable from the Higher Education Projects Development Fund, for the Department of Higher Education the following:

(A) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 21 of Act 766 of 2011, for the development of projects at State Institutions of Higher Education and the payment of project costs and expenses of the issuance of bonds of the Arkansas College Savings General Obligation Bonds Program, in a sum not to exceed.....\$3,050,209.

SECTION 27. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 28. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for

which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 29. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2012 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2012 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2012.
