AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
IMPROVEMENT APPROPRIATIONS FOR THE SECRETARY OF
STATE; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE SECRETARY OF STATE
REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION. There is hereby appropriated, to the Secretary of State, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Secretary of State the following:

(A) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 1 of Act 63 of 2011, for construction of Phase II of the Arkansas Fallen Firefighters' Memorial on the State Capitol grounds, in a sum not to exceed.....\$4,948.

(B) Effective July 1, 2012, the balance of the appropriation provided in Item (F) Section 1 of Act 63 of 2011, for construction, site preparation and maintenance of the Arkansas Fallen Firefighters' Memorial on the State Capitol Grounds, in a sum not to exceed.....\$50,000.

(C) Effective July 1, 2012, the balance of the appropriation provided in Item (A) Section 1 of Act 318 of 2011, for an upgrade of the existing electrical distribution system, in a sum not to exceed.....\$421,781.

(D) Effective July 1, 2012, the balance of the appropriation provided in Item (B) Section 1 of Act 318 of 2011, for the continuation of heating, ventilation, and air conditioning upgrades for the North End of the State



Capitol Building, in a sum not to exceed.....\$4,190,568.

(E) Effective July 1, 2012, the balance of the appropriation provided in Item (C) Section 1 of Act 318 of 2011, for an equipment upgrade of the existing fire alarm system for the State Capitol Building, in a sum not to exceed.....\$193,446.

(F) Effective July 1, 2012, the balance of the appropriation provided in Item (D) Section 1 of Act 318 of 2011, for replacement of damaged sidewalks, addition of lighting to unlit or dark areas, an upgrade of the irrigation system, and landscaping and plantings for the North Entry Promenade I and II of the State Capitol Grounds, in a sum not to exceed\$542,596.

(G) Effective July 1, 2012, the balance of the appropriation provided in Item (E) Section 1 of Act 318 of 2011, for "Green" initiatives for the State Capitol building, facilities, buildings and grounds including ventilation system cleaning, energy efficiencies and assessments, analyses and consulting services, recycling programs and/or related construction, renovation and equipping, in a sum not to exceed.....\$175,000.

SECTION 2. REAPPROPRIATION. There is hereby appropriated, to the Secretary of State, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Secretary of State the following:

(A) Effective July 1, 2012, the balance of the appropriation provided in Sections 30 and 34 of Act 692 of 2011, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$418,158.

SECTION 3. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General

Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 4. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2012 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2012 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2012.
