## For An Act To Be Entitled

AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL  
IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF  
HIGHER EDUCATION; AND FOR OTHER PURPOSES.

### Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER  
EDUCATION REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - HENDERSON STATE UNIVERSITY. There is hereby appropriated, to the Henderson State University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Henderson State University the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (B) Section 1 of Act 71 of 2012, for Phase I campus renovations, in a sum not to exceed.....\$2,200,000.

(B) Effective July 1, 2013, the balance of the appropriation provided in Item (C) Section 1 of Act 71 of 2012, for local area network infrastructure, in a sum not to exceed.....\$800,000.

(C) Effective July 1, 2013, the balance of the appropriation provided in Item (D) Section 1 of Act 71 of 2012, for deferred maintenance, in a sum not to exceed.....\$1,330,000.

(D) Effective July 1, 2013, the balance of the appropriation provided in Item (E) Section 1 of Act 71 of 2012, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$620,000.



SECTION 2. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY - GENERAL IMPROVEMENT. There is hereby appropriated, to the Southern Arkansas University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Southern Arkansas University the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (A) Section 2 of Act 71 of 2012, for construction of a University Agriculture Center, in a sum not to exceed.....\$1,100,000.

(B) Effective July 1, 2013, the balance of the appropriation provided in Item (B) Section 2 of Act 71 of 2012, for technology upgrades, in a sum not to exceed.....\$1,000,000.

(C) Effective July 1, 2013, the balance of the appropriation provided in Item (C) Section 2 of Act 71 of 2012, for renovation of the Bruce Center, in a sum not to exceed.....\$400,000.

(D) Effective July 1, 2013, the balance of the appropriation provided in Item (D) Section 2 of Act 71 of 2012, for deferred maintenance, in a sum not to exceed.....\$1,410,000.

(E) Effective July 1, 2013, the balance of the appropriation provided in Item (E) Section 2 of Act 71 of 2012, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$510,000.

(F) Effective July 1, 2013, the balance of the appropriation provided in Item (G) Section 2 of Act 71 of 2012, for constructing, equipping, personal services, maintenance and operating expenses of a Natural Resources Research Center for research of lignite and other natural resources in the State, in a sum not to exceed.....\$75,000.

(G) Effective July 1, 2013, the balance of the appropriation provided in Item (H) Section 2 of Act 71 of 2012, for construction/renovation/maintenance/critical maintenance/equipment/library resources, in a sum not to exceed.....\$100,000.

(H) Effective July 1, 2013, the balance of the appropriation provided in Item (I) Section 2 of Act 71 of 2012, for expenses of a lignite feasibility study, in a sum not to exceed.....\$32,194.

SECTION 3. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY - TRUST - OLIVER RECITAL HALL RESTORATION. There is hereby appropriated, to the Southern Arkansas University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Southern Arkansas University

the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (1) Section 30 of Act 233 of 2012, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$73,000.

SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - GENERAL IMPROVEMENT. There is hereby appropriated, to the Arkansas State University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (A) Section 4 of Act 71 of 2012, for construction, equipping, landscaping, personal services, operations, finishing, furnishing, and parking of a liberal arts building, in a sum not to exceed .....\$38,375,068.

(B) Effective July 1, 2013, the balance of the appropriation provided in Item (D) Section 4 of Act 71 of 2012, for deferred maintenance for classrooms, buildings and related infrastructure, in a sum not to exceed .....\$7,000,000.

(C) Effective July 1, 2013, the balance of the appropriation provided in Item (E) Section 4 of Act 71 of 2012, for classroom renovations, refurbishing, technology updates, equipment, furniture and other classroom needs and expenses, in a sum not to exceed.....\$5,000,000.

(D) Effective July 1, 2013, the balance of the appropriation provided in Item (F) Section 4 of Act 71 of 2012, for constructing, equipping, landscaping, parking lot, and other construction related costs of completing a liberal arts teaching building, in a sum not to exceed.....\$6,000,000.

(E) Effective July 1, 2013, the balance of the appropriation provided in Item (G) Section 4 of Act 71 of 2012, for construction and replacement of Wilson Hall, in a sum not to exceed.....\$4,000,000.

(F) Effective July 1, 2013, the balance of the appropriation provided in Item (H) Section 4 of Act 71 of 2012, for deferred maintenance, in a sum not to exceed.....\$3,690,000.

(G) Effective July 1, 2013, the balance of the appropriation provided in Item (I) Section 4 of Act 71 of 2012, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$2,030,000.

(H) Effective July 1, 2013, the balance of the appropriation provided in Item (J) Section 4 of Act 71 of 2012, for personal services, operating expenses, and grants to support the continuation of the Arkansas Delta Training and Education Consortium University Center Initiatives, in a sum not to exceed.....\$1,251,672.

(I) Effective July 1, 2013, the balance of the appropriation provided in Item (K) Section 4 of Act 71 of 2012, for acquisition, reconstruction, remodeling, personal services and operating expenses of heritage sites, in a sum not to exceed.....\$500,000.

(J) Effective July 1, 2013, the balance of the appropriation provided in Item (L) Section 4 of Act 71 of 2012, for construction/replacement of Wilson Hall, in a sum not to exceed.....\$4,000,000.

SECTION 5. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - TRUST - DYESS COLONY/JOHNNY CASH TOWN CENTER RESTORATION - PHASE III. There is hereby appropriated, to the Arkansas State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas State University the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (1) Section 30 of Act 233 of 2012, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$350,000.

SECTION 6. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY - GENERAL IMPROVEMENT. There is hereby appropriated, to the Arkansas Tech University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas Tech University the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (B) Section 8 of Act 71 of 2012, for construction of an academic classroom facility, in a sum not to exceed.....\$2,315,000.

(B) Effective July 1, 2013, the balance of the appropriation provided in Item (C) Section 8 of Act 71 of 2012, for renovation and critical maintenance of educational and general buildings, in a sum not to exceed .....\$935,000.

(C) Effective July 1, 2013, the balance of the appropriation provided in Item (D) Section 8 of Act 71 of 2012, for electrical system upgrade -

Ozark Campus, in a sum not to exceed.....\$175,000.

(D) Effective July 1, 2013, the balance of the appropriation provided in Item (E) Section 8 of Act 71 of 2012, for library software upgrade - Ozark Campus, in a sum not to exceed.....\$50,000.

(E) Effective July 1, 2013, the balance of the appropriation provided in Item (F) Section 8 of Act 71 of 2012, for deferred maintenance, in a sum not to exceed.....\$1,960,000.

(F) Effective July 1, 2013, the balance of the appropriation provided in Item (G) Section 8 of Act 71 of 2012, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$1,180,000.

SECTION 7. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY - TRUST - GIRLS' DOMESTIC SCIENCE AND ARTS BUILDING - PHASE II. There is hereby appropriated, to the Arkansas Tech University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas Tech University the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (1) Section 30 of Act 233 of 2012, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$300,000.

SECTION 8. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - GENERAL IMPROVEMENT. There is hereby appropriated, to the University of Arkansas, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (A) Section 10 of Act 71 of 2012, for construction, renovations, major maintenance, maintenance, furnishings, and purchase of equipment for the Arkansas School for Mathematics, Sciences and the Arts, in a sum not to exceed.....\$4,000,000.

(B) Effective July 1, 2013, the balance of the appropriation provided in Item (D) Section 10 of Act 71 of 2012, for construction, renovation, maintenance, personal services, equipment, and operational expenses for the Arkansas School for Mathematics, Sciences and the Arts, in a sum not to exceed.....\$2,000,000.

(C) Effective July 1, 2013, the balance of the appropriation provided

in Item (F) Section 10 of Act 71 of 2012, for personal services and operating expenses, improvements, renovation, and purchase of equipment for the Criminal Justice Institute, in a sum not to exceed.....\$9,450.

(D) Effective July 1, 2013, the balance of the appropriation provided in Item (H) Section 10 of Act 71 of 2012, for construction, equipment, maintenance, deferred maintenance, renovation, personal services and operating expenses of the Criminal Justice Institute, in a sum not to exceed .....\$3,743.

(E) Effective July 1, 2013, the balance of the appropriation provided in Item (J) Section 10 of Act 71 of 2012, for Archives and Photograph Preservation technology and equipment upgrades for the University of Arkansas - Arkansas Archeological Survey, in a sum not to exceed.....\$16,000.

(F) Effective July 1, 2013, the balance of the appropriation provided in Item (K) Section 10 of Act 71 of 2012, for renovation of the Cooperative Extension Service Headquarters Facility, Phase II for the University of Arkansas - Division of Agriculture, in a sum not to exceed.....\$1,875,000.

(G) Effective July 1, 2013, the balance of the appropriation provided in Item (L) Section 10 of Act 71 of 2012, for technology upgrades for the University of Arkansas - System, in a sum not to exceed.....\$50,000.

(H) Effective July 1, 2013, the balance of the appropriation provided in Item (M) Section 10 of Act 71 of 2012, for Cemetery Preservation technology and equipment upgrades for the University of Arkansas - Arkansas Archeological Survey, in a sum not to exceed.....\$25,000.

(I) Effective July 1, 2013, the balance of the appropriation provided in Item (N) Section 10 of Act 71 of 2012, for equipment upgrades for the University of Arkansas - Criminal Justice Institute, in a sum not to exceed .....\$150,000.

(J) Effective July 1, 2013, the balance of the appropriation provided in Item (O) Section 10 of Act 71 of 2012, for construction of a multi-purpose building for the University of Arkansas - Arkansas School for Mathematics, Science, and the Arts, in a sum not to exceed.....\$300,000.

(K) Effective July 1, 2013, the balance of the appropriation provided in Item (P) Section 10 of Act 71 of 2012, for renovation of Ozark Hall with Honors College Wing for the University of Arkansas - Fayetteville, in a sum not to exceed.....\$5,000,000.

(L) Effective July 1, 2013, the balance of the appropriation provided

in Item (Q) Section 10 of Act 71 of 2012, for technology upgrades for the University of Arkansas - Division of Agriculture, in a sum not to exceed .....\$1,625,000.

(M) Effective July 1, 2013, the balance of the appropriation provided in Item (R) Section 10 of Act 71 of 2012, for deferred maintenance, in a sum not to exceed.....\$9,800,000.

(N) Effective July 1, 2013, the balance of the appropriation provided in Item (S) Section 10 of Act 71 of 2012, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$4,380,000.

(O) Effective July 1, 2013, the balance of the appropriation provided in Item (W) Section 10 of Act 71 of 2012, for equipment and supplies to support the education and training of the Arkansas Law Enforcement Community by the Criminal Justice Institute, in a sum not to exceed.....\$25,821.

(P) Effective July 1, 2013, the balance of the appropriation provided in Item (AA) Section 10 of Act 71 of 2012, for maintenance and general operations, renovation, construction, personal services, equipment, printing and operational expenses of the Division of Agriculture, in a sum not to exceed.....\$111,961.

(Q) Effective July 1, 2013, the balance of the appropriation provided in Item (BB) Section 10 of Act 71 of 2012, for operations, personal services, construction, renovations, capital outlay, maintenance and expenses of the Arkansas School for Mathematics, Sciences and the Arts, in a sum not to exceed.....\$36,264.

(R) Effective July 1, 2013, the balance of the appropriation provided in Item (CC) Section 10 of Act 71 of 2012, for construction of a nanotechnology research center for the U of A - Fayetteville, in a sum not to exceed.....\$2,000,000.

(S) Effective July 1, 2013, the balance of the appropriation provided in Item (DD) Section 10 of Act 71 of 2012, for construction of an auditorium, scholarships, operations, equipment, improvements and renovations - U of A - Clinton School campus, in a sum not to exceed.....\$80,000.

SECTION 9. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - TRUST - PRESERVING THE PREHISTORIC HERITAGE OF ARKANSAS. There is hereby appropriated, to the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of

Arkansas the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (1) Section 30 of Act 233 of 2012, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$52,249.

SECTION 10. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - TRUST - ARCHIVING RECORDS AND PHOTOGRAPHS OF THE ARCHEOLOGICAL SURVEY. There is hereby appropriated, to the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (1) Section 30 of Act 233 of 2012, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$44,006.

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (1) Section 30 of Act 233 of 2012, for acquisition, management,

stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$19,753.

SECTION 16. REAPPROPRIATION - UNIVERSITY OF ARKANSAS FOR MEDICAL SCIENCES - GENERAL IMPROVEMENT. There is hereby appropriated, to the University of Arkansas for Medical Sciences, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas for Medical Sciences the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (A) Section 17 of Act 71 of 2012, for personal services and operating expenses of establishing and operating Sickle Cell Clinics and Outreach Efforts of the University of Arkansas for Medical Sciences - Adult Sickle Cell Disease Program, in a sum not to exceed.....\$200,000.

(B) Effective July 1, 2013, the balance of the appropriation provided in Item (I) Section 17 of Act 71 of 2012, for design and implementation of the Student Information System, in a sum not to exceed.....\$3,250,000.

(C) Effective July 1, 2013, the balance of the appropriation provided in Item (J) Section 17 of Act 71 of 2012, for renovation of the Clinical Research Center, in a sum not to exceed.....\$1,250,000.

(D) Effective July 1, 2013, the balance of the appropriation provided in Item (K) Section 17 of Act 71 of 2012, for deferred maintenance, in a sum not to exceed.....\$7,380,000.

(E) Effective July 1, 2013, the balance of the appropriation provided in Item (L) Section 17 of Act 71 of 2012, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$1,000,000.

SECTION 17. REAPPROPRIATION - UNIVERSITY OF ARKANSAS FOR MEDICAL SCIENCES - TRUST - PSYCHIATRIC RESEARCH INSTITUTE MEMORIAL GARDENS. There is hereby appropriated, to the University of Arkansas for Medical Sciences, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas for Medical Sciences the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (1) Section 30 of Act 233 of 2012, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$250,000.

SECTION 18. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - MONTICELLO - GENERAL IMPROVEMENT. There is hereby appropriated, to the University of Arkansas at Monticello, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas at Monticello the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (A) Section 19 of Act 71 of 2012, for renovations of the Music Building, in a sum not to exceed.....\$70,000.

(B) Effective July 1, 2013, the balance of the appropriation provided in Item (B) Section 19 of Act 71 of 2012, for construction of a General Education Building at the College of Technology - McGehee, in a sum not to exceed.....\$200,000.

(C) Effective July 1, 2013, the balance of the appropriation provided in Item (C) Section 19 of Act 71 of 2012, for renovation of the Math and Science Center, in a sum not to exceed.....\$1,800,000.

(D) Effective July 1, 2013, the balance of the appropriation provided in Item (D) Section 19 of Act 71 of 2012, for construction of a Workforce/ Collegiate center at the College of Technology - Crossett, in a sum not to exceed.....\$200,000.

(E) Effective July 1, 2013, the balance of the appropriation provided in Item (E) Section 19 of Act 71 of 2012, for costs associated with a new telephone system, in a sum not to exceed.....\$250,000.

(F) Effective July 1, 2013, the balance of the appropriation provided in Item (F) Section 19 of Act 71 of 2012, for technology infrastructure and recabling of campus buildings, in a sum not to exceed.....\$300,000.

(G) Effective July 1, 2013, the balance of the appropriation provided in Item (G) Section 19 of Act 71 of 2012, for technology infrastructure and wireless access equipment, in a sum not to exceed.....\$150,000.

(H) Effective July 1, 2013, the balance of the appropriation provided in Item (H) Section 19 of Act 71 of 2012, for deferred maintenance, in a sum not to exceed.....\$1,450,000.

(I) Effective July 1, 2013, the balance of the appropriation provided in Item (I) Section 19 of Act 71 of 2012, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$450,000.

SECTION 19. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - MONTICELLO - TRUST - TAYLOR HOUSE SITE. There is hereby appropriated, to the University of Arkansas at Monticello, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas at Monticello the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (I) Section 30 of Act 233 of 2012, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$100,000.

SECTION 20. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - PINE BLUFF. There is hereby appropriated, to the University of Arkansas at Pine Bluff, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas at Pine Bluff the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (F) Section 20 of Act 71 of 2012, for campus renovations and repair, in a sum not to exceed.....\$2,000,000.

(B) Effective July 1, 2013, the balance of the appropriation provided in Item (G) Section 20 of Act 71 of 2012, for technology upgrades, in a sum

not to exceed.....\$500,000.

(C) Effective July 1, 2013, the balance of the appropriation provided in Item (H) Section 20 of Act 71 of 2012, for deferred maintenance, in a sum not to exceed.....\$1,080,000.

(D) Effective July 1, 2013, the balance of the appropriation provided in Item (I) Section 20 of Act 71 of 2012, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$530,000.

(E) Effective July 1, 2013, the balance of the appropriation provided in Item (J) Section 20 of Act 71 of 2012, for a grant for personal services, operating expenses, construction, renovation and equipment to improve the Advance Science, Technology, Engineering and Mathematics (STEM) academic enrichment program and for conference center renovations and improvements, in a sum not to exceed.....\$2,300,000.

SECTION 21. REAPPROPRIATION - UNIVERSITY OF CENTRAL ARKANSAS - GENERAL IMPROVEMENT. There is hereby appropriated, to the University of Central Arkansas, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Central Arkansas the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (B) Section 21 of Act 71 of 2012, for internet cable upgrades costs, in a sum not to exceed.....\$660,000.

(B) Effective July 1, 2013, the balance of the appropriation provided in Item (C) Section 21 of Act 71 of 2012, for fiber replacement project costs, in a sum not to exceed.....\$1,200,000.

(C) Effective July 1, 2013, the balance of the appropriation provided in Item (D) Section 21 of Act 71 of 2012, for switch upgrade project costs, in a sum not to exceed.....\$2,490,000.

(D) Effective July 1, 2013, the balance of the appropriation provided in Item (E) Section 21 of Act 71 of 2012, for deferred maintenance, in a sum not to exceed.....\$2,920,000.

(E) Effective July 1, 2013, the balance of the appropriation provided in Item (F) Section 21 of Act 71 of 2012, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$2,100,000.

SECTION 22. REAPPROPRIATION - UNIVERSITY OF CENTRAL ARKANSAS - TRUST - OLD MAIN HALL RENOVATION. There is hereby appropriated, to the University of

Central Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Central Arkansas the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (1) Section 30 of Act 233 of 2012, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$152,000.

SECTION 23. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FORT SMITH.

There is hereby appropriated, to the University of Arkansas - Fort Smith, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas - Fort Smith the following:

(A) Effective July 1, 2013, the balance of the appropriation provided in Item (B) Section 23 of Act 71 of 2012, for the expansion and upgrade of the library, in a sum not to exceed.....\$2,750,000.

(B) Effective July 1, 2013, the balance of the appropriation provided in Item (C) Section 23 of Act 71 of 2012, for deferred maintenance, in a sum not to exceed.....\$1,150,000.

(C) Effective July 1, 2013, the balance of the appropriation provided in Item (D) Section 23 of Act 71 of 2012, for replacement and renewal of equipment and library holdings, in a sum not to exceed.....\$870,000.

(D) Effective July 1, 2013, the balance of the appropriation provided in Item (E) Section 23 of Act 71 of 2012, for personal services, operating expenses, and grants to support the continuation of the Arkansas Delta Training and Education Consortium University Center initiatives, in a sum not to exceed.....\$116,981.

SECTION 24. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds

otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 25. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 26. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2013 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2013 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2013.
