AN ACT TO AMEND ACT 3 OF THE REGULAR SESSION OF 2013,  
THE GENERAL APPROPRIATION ACT FOR THE ORDINARY  
EXPENSES OF THE EXECUTIVE, JUDICIAL AND LEGISLATIVE  
BRANCHES; AND FOR OTHER PURPOSES.

AN ACT TO AMEND ACT 3 OF THE REGULAR  
SESSION OF 2013, THE GENERAL  
APPROPRIATION ACT FOR THE ORDINARY  
EXPENSES OF THE EXECUTIVE, JUDICIAL AND  
LEGISLATIVE BRANCHES FOR THE 2013-2014  
FISCAL YEAR.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Section 1 of Act 3 of the Regular Session of 2013 is hereby amended to read as follows:

SECTION 1. APPROPRIATION - AUDITOR OF STATE DISBURSEMENTS. There is hereby appropriated, to the Auditor of State, to be payable from the Constitutional Officers Fund, for personal services and operating expenses of the Auditor of State - General Appropriations for the fiscal year ending June 30, 2014, the following:

SECTION 2. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2013 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2013 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2013.
