20 TO AUTHORIZE THE INTRODUCTION OF A
21 NONAPPROPRIATION BILL CONCERNING SECURITY
22 LICENSING; SCHOOL SECURITY; THE ARKANSAS
23 BOARD OF PRIVATE INVESTIGATORS AND
24 PRIVATE SECURITY AGENCIES; AND THE
25 TRANSFER OF POWERS AND DUTIES.

28 BE IT RESOLVED BY THE SENATE OF THE EIGHTY-NINTH GENERAL ASSEMBLY OF THE
29 STATE OF ARKANSAS:

30
31 That Senator Hutchinson is authorized to introduce a bill which as introduced
32 will read substantially as follows:
33

34 "For An Act To Be Entitled
35 AN ACT TO VEST CERTAIN SECURITY LICENSING AUTHORITY WITH THE DEPARTMENT OF
36 ARKANSAS STATE POLICE; TO ALLOW CERTAIN SCHOOL EMPLOYEES TO BE LICENSED AS



1 PRIVATE SECURITY OFFICERS; TO ABOLISH THE ARKANSAS BOARD OF PRIVATE
2 INVESTIGATORS AND PRIVATE SECURITY AGENCIES AND TRANSFER ITS POWERS AND
3 DUTIES; TO DECLARE AN EMERGENCY; AND FOR OTHER PURPOSES.

5 Subtitle

6 TO VEST CERTAIN SECURITY LICENSING AUTHORITY WITH THE STATE POLICE; TO
7 PROVIDE FOR SCHOOL SECURITY; TO ABOLISH THE ARKANSAS BOARD OF PRIVATE
8 INVESTIGATORS AND PRIVATE SECURITY AGENCIES; AND TO DECLARE AN EMERGENCY.

9
10 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

11
12 SECTION 1. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE
13 ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL, AND TEMPORARY LAW.
14 TRANSFER OF POWERS AND DUTIES.

15 (a) All powers and duties formerly assigned to the Arkansas Board of
16 Private Investigators and Private Security Agencies are transferred to the
17 Department of Arkansas State Police.

18 (b) The Governor shall issue an executive order transferring the
19 powers and duties of the Arkansas Board of Private Investigators and Private
20 Security Agencies to the Department of Arkansas State Police by a type 3
21 transfer as defined in § 25-2-106.

22
23 SECTION 2. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE
24 ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL, AND TEMPORARY LAW.
25 TRANSITION PLAN – CONTINUOUS SERVICE.

26 (a) The transfer of powers and duties occurs under this act, any and
27 all statutory authority, powers, duties, functions, records, authorized
28 positions, property, unexpended balances of appropriations, allocations, or
29 other funds of the Arkansas Board of Private Investigators and Private
30 Security Agencies shall be transferred to the Department of Arkansas State
31 Police only after the development of a transition plan is completed that will
32 ensure the efficient and effective transfer of the powers and duties of the
33 Arkansas Board of Private Investigators and Private Security Agencies to the
34 Department of Arkansas State Police so that there is continuous service
35 delivery to and protection of the people of the State of Arkansas.

36 (b) The Department of Arkansas State Police shall submit for review

1 any transition plan developed under this section to the House Judiciary
2 Committee and the Senate Judiciary Committee.

3
4 SECTION 3. Arkansas Code Title 17, Chapter 39, Subchapter 1, is
5 amended to read as follows.

6 Subchapter 1
7 - General Provisions

8
9 17-39-101. Title.

10 This chapter shall be known and may be cited as the "Polygraph
11 Examiners Licensing Act".

12
13 17-39-102. Definitions.

14 As used in this chapter:

15 (1) "Administrator" means the ~~Administrator of the Arkansas Board of~~
16 ~~Private Investigators and Private Security Agencies~~ administrator in charge
17 of licensing permitted under this subchapter that is employed by the
18 Department of Arkansas State Police;

19 (2) "~~Board Department~~" means the ~~Arkansas Board of Private~~
20 ~~Investigators and Private Security Agencies~~ Department of Arkansas State
21 Police created by § 17-40-201;

22 (3) "Intern" means a person who holds a valid polygraph examiner
23 intern license by the ~~board~~ department;

24 (4) "Internship" means the study of polygraph examinations and of the
25 administration of polygraph examinations by an intern under the personal
26 supervision and control of a licensed polygraph examiner as authorized by the
27 ~~board~~ department;

28 (5) "Person" means any natural person, firm, association,
29 copartnership, or corporation; and

30 (6) "Polygraph examiner" means any person who uses any device or
31 instrument to test or question individuals for the purpose of verifying truth
32 of statements.

33
34 17-39-103. Penalties.

35 (a) Any person who violates any provision of this chapter or any person
36 who falsely states or represents that he or she has been or is a properly

1 licensed polygraph examiner or intern shall be guilty of a misdemeanor.

2 (b) Upon conviction, that person shall be punished by a fine of not
3 less than one hundred dollars (\$100) nor more than one thousand dollars
4 (\$1,000) or by imprisonment in the county jail for a term of not to exceed
5 six (6) months, or both.

6

7 17-39-104. Injunction.

8 (a) If any person violates any provisions of this chapter, the
9 ~~Administrator of the Arkansas Board of Private Investigators and Private~~
10 ~~Security Agencies~~ administrator, upon direction of a majority of the ~~Arkansas~~
11 ~~Board of Private Investigators and Private Security Agencies~~ Department of
12 Arkansas State Police and in the name of the State of Arkansas, through the
13 Attorney General, shall apply in any circuit court of competent jurisdiction
14 for an order enjoining the violation or for an order enforcing compliance
15 with this chapter.

16 (b)(1) Upon the filing of a verified petition in the court, the court
17 or any judge thereof, if satisfied by affidavit or otherwise that the person
18 has violated this chapter, may issue a temporary injunction, without notice
19 or bond, enjoining the continued violation.

20 (2) If it is established that the person has violated or is
21 violating this chapter, the court or any judge thereof may enter a decree
22 perpetually enjoining the violation or enforcing compliance with this
23 chapter.

24 (c) In case of violation of any order or decree issued under the
25 provisions of this section, the court or any judge thereof may try and punish
26 the offender for contempt of court.

27 (d) Proceeding under this section shall be in addition to, and not in
28 lieu of, all other remedies and penalties provided by this chapter.

29

30 17-39-105. Evidence.

31 Nothing in this chapter shall be construed as permitting the results of
32 polygraph examinations to be introduced or admitted as evidence in a court of
33 criminal law.

34

35 17-39-106. ~~Board~~ Department of Arkansas State Police – Powers and
36 duties.

1 (a) ~~The Arkansas Board of Private Investigators and Private Security~~
2 ~~Agencies~~ Department of Arkansas State Police is authorized and empowered to
3 perform and carry out the functions and duties enumerated in this chapter
4 with respect to the licensing of polygraph examiners and to do and perform
5 all other acts incidental and necessary to the proper performance of the
6 functions and duties as prescribed in this chapter.

7 (b) The ~~board~~ department shall issue rules consistent with the
8 provisions of this chapter for the administration and enforcement of this
9 chapter and shall prescribe forms which shall be issued in connection
10 therewith.

11 (c) An order or a certified copy thereof, over the ~~board~~ department
12 seal and purporting to be signed by the ~~board~~ department members, shall be
13 prima facie proof that the signatures are the genuine signatures of the ~~board~~
14 department members and that the ~~board~~ department members are fully qualified
15 to act.

16 (d)(1) ~~The position of Administrator of the Arkansas Board of Private~~
17 ~~Investigators and Private Security Agencies is created.~~ The Director of the
18 Department of Arkansas State Police, or his or her designated representative,
19 shall serve as the administrator.

20 (2) The administrator ~~shall not be a member of the board,~~ shall
21 perform duties prescribed by the ~~board~~ department, and shall have no
22 financial or business interests, contingent or otherwise, in any security
23 services contractor or investigating company.

24 (e) All legal process and all documents required by law to be served
25 upon or filed with the ~~board~~ department shall be served or filed with the
26 administrator at the designated office of the ~~board~~ department.

27 (f) All official records of the ~~board~~ department or affidavits by the
28 administrator as to the content of the records shall be prima facie evidence
29 of all matters required to be kept by the ~~board~~ department.

30
31 17-39-107. Disposition of funds.

32 (a) All fees collected under the provisions of this chapter shall be
33 deposited into the State Treasury to the credit of the Department of Arkansas
34 State Police Fund.

35 (b)(1) All funds received under this chapter by the ~~Arkansas Board of~~
36 ~~Private Investigators and Private Security Agencies~~ Department of Arkansas

1 State Police shall be deposited into the State Treasury as special revenues
2 to the credit of the fund.

3 (2) Money remaining at the end of the fiscal year shall not
4 revert to any other fund but shall carry over to the next fiscal year.

5
6 17-39-109. Instrumentation.

7 (a) Every polygraph examiner shall use an instrument which records
8 visually, permanently, and simultaneously:

- 9 (1) A subject's cardiovascular pattern;
- 10 (2) Electrodermal activity; and
- 11 (3) A subject's respiratory pattern.

12 (b) Patterns of other physiological changes in addition to those
13 described in this section may also be recorded.

14
15 SECTION 4. Arkansas Code Title 17, Chapter 39, Subchapter 2, is
16 amended to read as follows.

17 Subchapter 2
18 - Licensing

19
20 17-39-201. License required.

21 It shall be unlawful for any person, including a city, county, or state
22 employee, to administer polygraph examinations or attempt to hold himself or
23 herself out as a polygraph examiner without a license approved and issued by
24 the ~~Arkansas Board of Private Investigators and Private Security Agencies~~
25 Department of Arkansas State Police.

26
27 17-39-202. Qualifications.

28 (a) A person is qualified to receive a license as an examiner who:

- 29 (1) Is at least twenty-one (21) years of age;
- 30 (2) Has not been found guilty of or pleaded guilty or nolo
31 contendere to a felony or a misdemeanor involving moral turpitude;

32 (3) Holds a baccalaureate degree from a college or university
33 accredited by the American Association of Collegiate Registrars and
34 Admissions Officers or, in lieu thereof, has five (5) consecutive years of
35 active investigative experience immediately preceding his or her application;
36 and

1 (4) Is a graduate of a polygraph examiners course approved by
2 the ~~Arkansas Board of Private Investigators and Private Security Agencies~~
3 Department of Arkansas State Police and has satisfactorily completed not less
4 than six (6) months of internship training.

5 (b)(1) Prior to the issuance of a license, the applicant must furnish
6 evidence of a surety bond or insurance policy to the ~~board~~ department.

7 (2) The surety bond or insurance policy shall be in the sum of
8 five thousand dollars (\$5,000).

9 (3) The bond shall be conditioned that the obligor therein will
10 pay to the extent of the face amount of the surety bond or insurance policy
11 all judgments which may be recovered against the licensee by reason of any
12 wrongful or illegal acts committed by him or her in the course of his or her
13 examinations.

14

15 17-39-203. Original application.

16 (a) Applications for original licenses shall be made to the
17 ~~Administrator of the Arkansas Board of Private Investigators and Private~~
18 ~~Security Agencies~~ administrator in writing under oath on forms prescribed by
19 the ~~Arkansas Board of Private Investigators and Private Security Agencies~~
20 Department of Arkansas State Police and shall be accompanied by the required
21 fee, which is not refundable.

22 (b) Any such application shall require the information that in the
23 judgment of the ~~board~~ department will enable it to pass on the qualifications
24 of the applicant for a license.

25

26 17-39-204. Agent for service for nonresident interns and licensees.

27 (a) In addition to other application requirements, a licensee or
28 intern who does not maintain a place of business in Arkansas shall file with
29 the ~~Arkansas Board of Private Investigators and Private Security Agencies~~
30 Department of Arkansas State Police an irrevocable consent that:

31 (1) Actions against the applicant may be filed in any
32 appropriate court of any county or municipality of this state in which the
33 plaintiff resides or in which some part of the transaction occurred out of
34 which the alleged cause of action arose; and

35 (2) Process on the action may be served on the applicant by
36 leaving two (2) copies thereof with the ~~Administrator of the Arkansas Board~~

1 ~~of Private Investigators and Private Security Agencies~~ administrator.

2 (b) The consent shall stipulate and agree that the service of process
3 shall be taken and held to be valid and binding for all purposes.

4 (c) The administrator shall immediately send one (1) copy of the
5 process to the applicant at the address shown on the records of the ~~board~~
6 department by registered or certified mail.

7

8 17-39-205. License based on reciprocity.

9 An applicant who is a polygraph examiner licensed under the laws of
10 another state of the United States may be issued a two-year license by the
11 ~~Arkansas Board of Private Investigators and Private Security Agencies~~
12 Department of Arkansas State Police upon payment of a fee of one hundred and
13 twenty dollars (\$120) and the production of satisfactory proof that the
14 licensee meets the requirements of this section:

15 (1) The applicant must meet the requirements of § 17-39-202;

16 (2) The applicant is at least twenty-one (21) years of age;

17 (3) The requirements of § 17-39-202(3) and (4) may be waived by the
18 ~~board~~ department for the licensing of polygraph examiners in the particular
19 state or territory of the United States were at the date of the applicant's
20 licensing therein substantially equivalent to the requirements now in force
21 in this state;

22 (4) The applicant had lawfully engaged in the administration of
23 polygraph examinations under the laws of that state for at least two (2)
24 years prior to his or her application for a license under this chapter; and

25 (5) The other state grants similar reciprocity to license holders of
26 this state.

27

28 17-39-206. Internship license.

29 ~~Upon approval by the Administrator of the Arkansas Board of~~
30 ~~Private Investigators and Private Security Agencies, the~~ The administrator
31 shall issue an internship license to an intern, provided that he or she
32 applies for the license and pays the required fee within ten (10) days prior
33 to the commencement of his or her internship. The application shall contain
34 such information as may be required by the ~~Arkansas Board of Private~~
35 ~~Investigators and Private Security Agencies~~ Department of Arkansas State
36 Police.

1 (b) A person is qualified to receive an internship license if he or
2 she:

- 3 (1) Is at least twenty-one (21) years of age;
- 4 (2) Has not been found guilty of or pleaded guilty or nolo
5 contendere to any felony or a misdemeanor involving moral turpitude;
- 6 (3) Holds a baccalaureate degree from a college or university
7 accredited by the American Association of Collegiate Registrars and
8 Admissions Officers or, in lieu thereof, has five (5) consecutive years of
9 active investigative experience immediately preceding his or her application;
10 and
- 11 (4) Is a graduate of a polygraph examiners course approved by
12 the ~~board~~ department.

13 (c) An internship license shall be valid for the term of twelve (12)
14 months from the date of issue. It may be renewed for any term not to exceed
15 six (6) months upon good cause shown to the ~~board~~ department.

16
17 17-39-207. Examination – Fees.

18 The fees to be paid for licenses shall be as follows:

- 19 (1) For an original two-year polygraph examiner’s license, one hundred
20 twenty dollars (\$120);
- 21 (2) For a one-year or less internship license, thirty dollars
22 (\$30.00);
- 23 (3) For the issuance of a duplicate polygraph examiner’s license or
24 internship license, fifteen dollars (\$15.00);
- 25 (4) For a polygraph examiner’s two-year renewal license, fifty dollars
26 (\$50.00);
- 27 (5) For the renewal of an internship license past six (6) months,
28 twenty-five dollars (\$25.00); and
- 29 (6) For the issuance of an optional wallet-size polygraph examiner
30 licensee or intern photo identification card, fifteen dollars (\$15.00).

31
32 17-39-208. Display of license and signature.

33 A license or the photo identification card issued by the ~~Arkansas Board~~
34 ~~of Private Investigators and Private Security Agencies~~ Department of Arkansas
35 State Police must be prominently displayed at the place of business of the
36 polygraph examiner or at the place of internship.

17-39-209. Notification of address change.

Notice in writing shall be given to the ~~Administrator of the Arkansas Board of Private Investigators and Private Security Agencies~~ administrator by the licensed examiner of any change of principal business location within thirty (30) days of the time he or she changes the location.

17-39-210. Expiration and renewal.

(a) Each polygraph examiner’s license shall be issued for the term of two (2) years and, unless suspended or revoked, shall be renewed with such documentation as may be prescribed by the ~~Arkansas Board of Private Investigators and Private Security Agencies~~ Department of Arkansas State Police.

(b) A polygraph examiner whose license has expired less than six (6) months may renew the license by making a renewal application and paying the renewal fees and a late fee of twenty dollars (\$20.00).

(c) However, any polygraph examiner’s license that has been expired for more than six (6) months shall be deemed permanently expired, and the licensee shall begin the process again as a new applicant.

(d) The calculation of the late fee or expiration time may be waived for a person who demonstrates that he or she was on active duty with the armed forces of the United States or the National Guard at the time of expiration.

(e) The requirements, as set out by the ~~board~~ department, must be met before renewal, including:

- (1) Payment of all necessary fees; and
- (2) Providing the ~~board~~ department with proof of continuing polygraph examiner education of at least fourteen (14) hours received in the most recent two-year period by a training course approved by the ~~board~~ department.

17-39-211. Refusal, denial, suspension, revocation – Grounds.

The ~~Arkansas Board of Private Investigators and Private Security Agencies~~ Department of Arkansas State Police may deny, suspend, or revoke a license on any one (1) or more of the following grounds:

- (1) Failure to inform a subject to be examined as to the nature of the

1 examination;

2 (2) Failure to inform a subject to be examined that his or her
3 participation in the examination is voluntary;

4 (3) Any violation of law or the rules of the ~~board~~ department or
5 failure to meet the qualifications for licensure;

6 (4) Material misstatement in any application for license under this
7 chapter;

8 (5) Any misrepresentation or false promises or causing to be printed
9 any false or misleading advertisement for the purpose of directly or
10 indirectly obtaining business or interns;

11 (6) Demonstration of unworthiness or incompetency to act as a
12 polygraph examiner as defined by this chapter;

13 (7) Allowing one's license under this chapter to be used by any
14 unlicensed person in violation of the provisions of this chapter;

15 (8) Willfully aiding or abetting another in the violation of this
16 chapter or rule issued pursuant to it;

17 (9) Failure within a reasonable time to provide information requested
18 by the ~~Administrator of the Arkansas Board of Private Investigators and~~
19 ~~Private Security Agencies~~ administrator as the result of a formal complaint
20 to the ~~board~~ department, which would indicate a violation of this chapter; or

21 (10) Failure to inform the subject of the polygraph examination of the
22 results of the examination if so requested.

23

24 17-39-212. Background checks.

25 (a) Each first-time applicant and applicant for license renewal shall
26 be required to apply to the Identification Bureau of the Department of
27 Arkansas State Police for a state and national criminal background check to
28 be conducted by the Identification Bureau of the Department of Arkansas State
29 Police and the Federal Bureau of Investigation.

30 (b) The check shall conform to applicable federal standards and shall
31 include the taking of fingerprints.

32 (c) The applicant shall sign a release of information to the ~~Arkansas~~
33 ~~Board of Private Investigators and Private Security Agencies~~ Department of
34 Arkansas State Police and shall be responsible for the payment of any fee
35 associated with the criminal background check.

36 (d) Upon completion of the criminal background check, the

1 Identification Bureau of the Department of Arkansas State Police shall
2 forward to the ~~board~~ department all releasable information obtained
3 concerning the applicant.

4

5 17-39-213. Refusal, denial, suspension, revocation – Proceedings.

6 (a)(1)(A) When there is cause to deny an application or suspend or
7 revoke the license of any polygraph examiner, the ~~Arkansas Board of Private~~
8 ~~Investigators and Private Security Agencies~~ Department of Arkansas State
9 Police not less than thirty (30) days before denial, suspension, or
10 revocation action is taken, shall notify the person in writing, in person, or
11 by certified mail at the last address supplied to the ~~board~~ department by the
12 person.

13 (B) This notice shall include notification of the
14 impending denial, suspension, or revocation, the reasons therefor, and of his
15 or her right to an administrative hearing for the purpose of determining
16 whether or not the evidence is sufficient to warrant the denial, suspension,
17 or revocation action proposed to be taken by the ~~board~~ department.

18 (2) Upon receipt by the ~~board~~ department of the written request,
19 an opportunity for an administrative hearing shall be afforded as early as is
20 practicable.

21 (3) The administrative hearing in those cases shall be before
22 the ~~board~~ department.

23 (b)(1) The ~~board~~ department shall conduct the administrative hearings,
24 and it is authorized to administer oaths and issue subpoenas for the
25 attendance of witnesses and the production of relevant books, papers,
26 documents, etc.

27 (2) On the basis of the evidence submitted at the hearing, the
28 ~~Administrator of the Arkansas Board of Private Investigators and Private~~
29 ~~Security Agencies~~ administrator shall take whatever action he or she deems
30 necessary in denying the application or suspending or revoking the license.

31 (c)(1) Upon the revocation or suspension of any license, the licensee
32 shall immediately surrender the license or licenses to the administrator of
33 the ~~board~~ department.

34 (2) Failure of a licensee to do so shall be a violation of this
35 chapter, and upon conviction the licensee shall be subject to the penalties
36 set forth in § 17-39-103.

1 (3) At any time after the suspension or revocation of any
2 license, the administrator shall restore it to the former licensee upon the
3 written recommendations of the ~~board~~ department.

4
5 17-39-214. Refusal, suspension, revocation – Appeal.

6 (a) Any person dissatisfied with the action of the ~~Arkansas Board of~~
7 ~~Private Investigators and Private Security Agencies~~ Department of Arkansas
8 State Police in denying, suspending, or revoking his or her license may
9 appeal under the Arkansas Administrative Procedure Act, § 25-15-201 et seq.

10 (b) The ~~board~~ department shall be represented in such appeals by the
11 Attorney General or any of his or her assistants.

12
13 17-39-215. Rules.

14 The ~~Arkansas Board of Private Investigators and Private Security~~
15 ~~Agencies~~ Department of Arkansas State Police may promulgate rules to permit
16 the efficient administration of this subchapter.

17
18 SECTION 5. Arkansas Code Title 17, Chapter 39, Subchapter 3, is
19 amended to read as follows.

20 Subchapter 3

21 – Voice Stress Analysis Examiners

22
23 17-39-301. Definitions.

24 As used in this subchapter:

25 (1) “Administrator” means the ~~Administrator of the Arkansas Board of~~
26 ~~Private Investigators and Private Security Agencies~~ administrator in charge
27 of licensing permitted under this subchapter that is employed by the
28 Department of Arkansas State Police;

29 (2) “~~Board~~ Department” means the ~~Arkansas Board of Private~~
30 ~~Investigators and Private Security Agencies~~ Department of Arkansas State
31 Police created by § 17-40-201;

32 (3) “Voice stress analysis” means the procedure for analyzing the
33 responses of an individual to a specific set of questions;

34 (4) “Voice stress analysis examiner” means an individual who has been
35 trained in the operation of a voice stress analysis machine and who maintains
36 a current certificate from a recognized training facility; and

1 (5) "Voice stress analysis machine" means a device which has the
2 ability to electronically analyze the responses of an individual to a
3 specific set of questions and to record the analysis, both digitally and on a
4 graph.

5
6 17-39-302. Examinations not admissible in criminal proceedings.

7 Nothing contained in this subchapter shall be construed to permit the
8 results of any voice stress analysis examination to be introduced or admitted
9 as evidence in any criminal proceeding.

10

23 (2) The licensee or his or her manager for a Class E Level 1
 24 shall have two (2) years from July 30, 1999, to obtain the aforementioned

 27 his or her manager applicant shall show proof of National Burglar and Fire

23 disciplinary action.

24 (a) The ~~Arkansas Board of Private Investigators and Private Security~~
25 ~~Agencies~~ Department of Arkansas State Police may revoke, place on probation,
26 or suspend any registration, license, or security officer commission and may
27 either fine in an amount not to exceed one thousand dollars (\$1,000) for each
28 violation of this chapter or reprimand any registrant, licensee, or
29 commissioned security officer, or both, or the ~~board~~ department may deny an
30 application for a registration, license, or security officer commission, or

30 (2) The requirements for licensing in the particular state or

10 (a) The Director of the Department of Arkansas State Police may issue
11 a security guard license under § 17-40-309(b)(8) to a person who is employed
12 at a school and who will be engaged in ensuring school safety and emergency
13 response.

14 (b) In addition to any class or instruction required by the department
15 under this chapter, the following training is required for a license under §
16 17-40-309(b)(8):

17 (1) Fundamental use of firearms training, including firearm
18 safety drills, tactics, and required qualification on an approved course of
19 fire;

20 (2) Active shooter training;

21 (3) Active shooter simulation scenarios;

22 (4) Trauma care;

23 (5) Defensive tactics; and

24 (6) Weapon retention.

25 (c) A person may not be issued a school security license under this
26 subchapter if, as part of his or her employment, he or she is engaged in
27 classroom instruction at the school district, public charter school, or
28 private school where he or she is employed.

31 SECTION 9. EMERGENCY CLAUSE. It is found and determined by the
32 General Assembly of the State of Arkansas that the powers and duties of the
33 Arkansas Board of Private Investigators and Private Security Agencies can
34 easily be absorbed by the Department of Arkansas State Police; that the
35 transfer of the board's powers and duties to the department is economically
36 and administratively sound, as well as demonstrates good, efficient governing

1 of the State and the resources of its citizens; and that this act is
2 immediately necessary because the immediate transition of the duties and
3 powers of the board should occur immediately due to the number of licensees
4 affected by the licensing and administrative requirements. Therefore, an
5 emergency is declared to exist, and this act being immediately necessary for
6 the preservation of the public peace, health, and safety shall become
7 effective on:

8 (1) The date of its approval by the Governor;

9 (2) If the bill is neither approved nor vetoed by the Governor,
10 the expiration of the period of time during which the Governor may veto the
11 bill; or

12 (3) If the bill is vetoed by the Governor and the veto is
13 overridden, the date the last house overrides the veto.
