HOUSE BILL 1729

## For An Act To Be Entitled

AN ACT TO CREATE THE ARKANSAS SUNSET ACT OF 2015; TO PROVIDE FOR SYSTEMATIC REVIEW OF AGENCIES; TO ENCOURAGE EFFICIENT ADMINISTRATION OF GOVERNMENT FUNCTIONS; AND FOR OTHER PURPOSES.

### Subtitle

TO CREATE THE ARKANSAS SUNSET ACT OF 2015; TO PROVIDE FOR SYSTEMATIC REVIEW OF AGENCIES; AND TO ENCOURAGE EFFICIENT ADMINISTRATION OF GOVERNMENT FUNCTIONS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. DO NOT CODIFY. Legislative intent.

The General Assembly finds that:

(1) It is essential to the conservation of taxpayer dollars that state agencies operate in a cost-effective manner;

(2) It is essential to the growth of the economy that state agencies assist small businesses in this state by eliminating overly burdensome, antiquated, and unnecessary regulations;

(3) Regular review of state agencies, including without limitation their rules, standards, employment practices, funding, and spending, will assist the General Assembly in determining whether the state agency is performing its necessary functions in the most efficient manner possible; and

(4) State agencies that do not effectively serve a public peace, health, or safety function should be restructured or eliminated.



SECTION 2. Arkansas Code Title 25 is amended to add an additional chapter to read as follows:

CHAPTER 43

ARKANSAS SUNSET ACT OF 2015

25-43-101. Title.

This chapter shall be known as and may be cited as the "Arkansas Sunset Act of 2015".

25-43-102. Definition.

As used in this chapter "state agency" means any department, agency, board, commission, office, or other authority of the State of Arkansas.

25-43-103. Sunset Review Subcommittee.

(a) There is created the Sunset Review Subcommittee that shall be a subcommittee of the Joint Performance Review Committee.

(b) The voting membership of the subcommittee shall be composed of:

(1) No more than seven (7) members of the House of Representatives appointed by the Speaker of the House of Representatives from the membership of the House Joint Performance Review Committee; and

(2) No more than seven (7) Senate members appointed by the President Pro Tempore of the Senate.

(3)(A) The President Pro Tempore of the Senate shall determine the Senate cochair and vice chair of the subcommittee from the membership of the Senate Performance Review Committee.

(B) The Speaker of the House of Representatives shall determine the House cochair and the vice chair of the subcommittee from the membership of the House Performance Review Committee.

(4) For the interim meetings, legislative members shall be entitled to reimbursement for expenses and per diem at the same rate and from the same source as provided by law for attending other meetings of the interim committee and interim subcommittee.

25-43-104. Staff.

The Bureau of Legislative Research and Legislative Council shall provide staff support for the Sunset Review Subcommittee.

25-43-105. State agency report to the Sunset Review Subcommittee.

(a) Before October 30 of every odd-numbered year before the year in which a state agency is to be reviewed under this chapter, the state agency shall file a written report with the Sunset Review Subcommittee

(b) The written report under this section shall:

(1) Address the following:

(A) Efficiency and effectiveness of the agency's advisory boards or committees;

(B) Success in achieving the agency's mission, goals, and objectives;

(C) Performance of any duties not authorized by statute;

(D) Authority for specific duties performed by the agency;

(E) Necessity of the duties performed by the agency;

(F) The agency's authority related to fees, inspections, enforcement, and penalties;

(G) Ways the agency's functions and operations can be less burdensome or restrictive and still adequately protect and serve the public;

(H) The extent that the agency's programs and jurisdiction duplicate those of other agencies and how well the agency coordinates with those agencies;

(I) How well the agency complied with state and federal requirements regarding equal employment opportunity, the rights and privacy of individuals, and purchasing guidelines for historically underutilized businesses;

(J) How effectively the agency enforces rules on potential conflicts of interest of its employees;

(K) How effectively and efficiently the agency complies with the Freedom of Information Act of 1967, § 25- 19-101 et seq.;

(L) Whether abolishing the agency would cause federal government intervention or loss of federal funds;

(M) Whether the agency's statutory reporting requirements effectively fulfill a useful purpose;

(N) If the agency is a professional licensing agency,

whether:

(i) The agency's professional licensing program serve a meaningful public interest and provide the least restrictive form of regulation needed to protect the public interest;

(ii) The program's regulatory objective be achieved through market forces, private certification, and accreditation programs or through enforcement of other law;

(iii) The skill and training requirements for a license are consistent with a public interest, whether they impede applicants, particularly those with moderate or low incomes, from entering the occupation; and

(iv) There is an impact of the regulation on competition, consumer choice, and the cost of services;

(2) Recommend less restrictive or alternate methods of performing agency functions that could adequately protect the public; and

(3) Include any other information that:

(A) The state agency considers appropriate; or

(B) Is requested by the subcommittee.

25-43-106. Subcommittee duties.

(a) Before September 1 of every even-numbered year before the year in which a state agency subject to this chapter is to be reviewed under this chapter, the Sunset Review Subcommittee shall:

(1) Review and take action necessary to verify the reports submitted by the state agency under § 25-43-105;

(2) Consult the Legislative Council, the office of the Governor, the Legislative Auditor, and the Director of the Department of Finance and Administration concerning the reports filed under § 25-43-105 and the criteria under § 25-43-108;

(3) Conduct a performance evaluation of the state agency based on the criteria provided in § 25-43-108 and prepare a written report;

(4) Hold one (1) or more public meetings at which public comment and explanation by the agency are allowed; and

(5) Review the implementation of subcommittee recommendations contained in the reports presented to the General Assembly during the preceding legislative session.

(b) The written report prepared by the subcommittee under subdivision (a)(3) of this section shall be considered a public record.

25-43-107. Subcommittee report.

(a)(1) At each regular session of the General Assembly, the Sunset Review Subcommittee shall present to the General Assembly a:

(A) Report on the state agencies scheduled to be reviewed on June 30 of the year in which the regular session occurs; and

(B) The subcommittee's recommendations based on the matters prescribed by § 25-43-109.

(2) The General Assembly shall forward a copy of the report to the Governor, the Lieutenant Governor, and the Legislative Auditor for their review.

(b) The subcommittee's report shall include:

(1) Its specific findings regarding each of the criteria prescribed by § 25-43-108; and

(2) Any other information the subcommittee deems necessary for a complete evaluation of the state agency.

25-43-108. Criteria for review.

The Sunset Review Subcommittee and its staff shall consider the following criteria in determining whether the state agency remains cost effective and performs its intended functions:

(1) The efficiency with which the state agency operates;

(2) An identification of the objectives intended for the state agency;

(3) An identification of the public interest that the state agency was intended to address;

(4) An identification of the extent to which the objectives of the agency have been achieved,

(5) An identification of the activities of the state agency and the legal authority for these activities;

(6) An assessment of less restrictive or alternate methods of performing any regulation that the state agency performs that could adequately protect the public;

(7) The extent to which the state agency is needed and is used;

(8) The extent to which the jurisdiction of the state agency and the programs administered by the state agency overlap or duplicate those of other state agencies and the extent to which the programs administered by the state agency can be consolidated with the programs of other state agencies;

(9) Whether the state agency has recommended to the legislature statutory changes calculated to be of benefit to the public rather than to an occupation, a business, or an institution that the state agency regulates;

(10) The promptness and effectiveness with which the state agency disposes of complaints concerning persons affected by the state agency;

(11) The extent to which the state agency has encouraged participation by the public in making the state agency's rules and decisions as opposed to participation solely by those the state agency regulates and the extent to which the public participation has resulted in rules compatible with the objectives of the state agency;

(12) The extent to which the state agency has complied with the applicable requirements of:

(A) An agency of the United States or of this state regarding equality of employment opportunity and the rights and privacy of individuals; and

(B) State law and applicable rules of any state agency regarding purchasing goals and programs for historically underutilized businesses;

(13) The extent to which changes are necessary in the enabling statutes of the state agency so that the state agency can adequately comply with the criteria listed in this section;

(14) The extent to which the state agency issues and enforces rules relating to potential conflicts of interest of its employees;

(15) The extent to which the state agency follows record management practices that enable it to respond efficiently to requests for public information;

(16) The effect of federal intervention or loss of federal funds if the state agency is abolished; and

(17) Any other factor the subcommittee deems relevant.

25-43-109. Recommendations.

(a) In its report on a state agency, the Sunset Review Subcommittee shall:

(1) Make recommendations on the continuation, termination, or reorganization of each affected state agency and on the need for the performance of the functions of the state agency;

(2) Make recommendations on the consolidation, transfer, or reorganization of programs within state agencies not under review when the programs duplicate functions performed in state agencies under review;

(3) Recommend appropriation levels for each state agency for which termination or reorganization is recommended under subdivision (a)(1) or subdivision (a)(2) of this section; and

(4) Include drafts of legislation necessary to carry out the subcommittee's recommendations under subdivisions (a)(1) and (2) of this section.

(b)(1) The General Assembly shall forward a copy of the report to the Legislative Auditor.

(2) Based on a risk assessment of and subject to the Legislative Joint Auditing Committee's approval of the recommendations, including the examination in the audit plan under § 25-43-110, the Legislative Auditor may examine the recommendations that do not require a statutory change and include as part of the next approved audit of the state agency a report on whether the state agency has implemented the recommendations and, if so, in what manner.

25-43-110. Review of certain state agencies.

In the two-year period preceding the date scheduled for the review of a state agency under this chapter, the Sunset Review Subcommittee may by majority vote of the subcommittee exempt from the provisions of this chapter relating to staff reports, hearings, and evaluations a state agency that has been inactive for a period of two (2) years preceding the date the state agency is scheduled for review.

25-43-111. Monitoring of recommendations.

During each regular legislative session, the Sunset Review Subcommittee shall monitor legislation affecting state agencies that have undergone review under this chapter.

25-43-112. Subpoena power.

(a)(1) The Sunset Review Subcommittee may issue process to compel the attendance of witnesses and the production of books, records, papers, and other objects necessary or proper for the purposes of the subcommittee proceedings.

(2) The process may be served on a witness at any place in this state.

(b) If a majority of the subcommittee directs the issuance of a subpoena, the chair of the subcommittee shall issue the subpoena in the name of the subcommittee.

(c) If the chair is absent, the chair's designee may issue a subpoena or other process in the same manner as the chair.

(d)(1) If necessary to obtain compliance with a subpoena or other process, the subcommittee may issue attachments.

(2) The attachments may be addressed to and served by any peace officer in this state.

(e) Testimony taken under subpoena shall be reduced to writing and given under oath subject to the penalty of perjury.

(f) A witness who attends a subcommittee proceeding under process is entitled to the same mileage and per diem as a witness who appears before a grand jury in this state.

25-43-113. Assistance and access to state agencies.

(a)(1) The Sunset Review Subcommittee may request the assistance of state agencies and officers.

(2) When assistance is requested, a state agency or officer may assist the subcommittee.

(b) In carrying out its functions under this chapter, the subcommittee or its designated staff member may inspect the records, documents, and files of any state agency.

25-43-114. Records protected from disclosure.

A record held by another entity that is confidential by law and that the Sunset Review Subcommittee receives in connection with the performance of the subcommittee's functions under this chapter or another law remains

confidential and is excepted from the Freedom of Information Act of 1967, § 25-19-101 et seq.

25-43-115. Gifts and grants.

(a) The Sunset Review Subcommittee may accept gifts, grants, and donations from any organization described in Section 501(c)(3) of the Internal Revenue Code, 26 U.S.C. § 501(c)(3), as it existed on January 1, 2005, for the purpose of funding any activity under this chapter.

(b) All gifts, grants, and donations shall be:

(1) Accepted in an open meeting by a majority of the voting members of the subcommittee; and

(2) Reported in the public record of the subcommittee with the name of the donor and the purpose of the gift, grant, or donation.

25-43-116. Attrition.

Whenever possible, state government is encouraged to utilize attrition as a long-term approach to reducing state agency costs and as a means of saving taxpayer money.

25-43-117. Review of proposed legislation creating regulatory state agency.

(a) Each bill filed in the General Assembly that would create a new state agency having regulatory authority shall be forwarded to the Sunset Review Subcommittee.

(b) The subcommittee shall review the bill to determine if:

(1) The proposed regulatory functions or other functions of the state agency or committee may be administered by one (1) or more existing state agencies;

(2) The form of regulation, if any, proposed by the bill is the least restrictive form of regulation that will adequately protect the public;

(3) The bill provides for adequate public input regarding any regulatory function proposed by the bill; and

(4) The bill provides for adequate protection against conflicts of interest within the state agency.

(c) After reviewing the bill, the subcommittee shall forward a written comment on the legislation to the sponsor of the bill and to the chair of the

committee to which the bill is referred.

25-43-118. Rules.

The Sunset Review Subcommittee shall promulgate rules necessary to carry out the provisions of this chapter.

25-43-119. Schedule for review

(a) The following state agencies and all departments, boards, commissions, institutions, divisions, programs, services, advisory committees, and councils of the state agencies shall be reviewed by June 30, 2017, and by June 30 of every twelfth year after June 30, 2017:
