## For An Act To Be Entitled

AN ACT TO MAKE TECHNICAL CORRECTIONS TO TITLE 10 OF  
THE ARKANSAS CODE CONCERNING THE GENERAL ASSEMBLY;  
AND FOR OTHER PURPOSES.

## Subtitle

TO MAKE TECHNICAL CORRECTIONS TO TITLE 10  
OF THE ARKANSAS CODE CONCERNING THE  
GENERAL ASSEMBLY.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code § 10-3-303(g)(1)(C), concerning reports that may be required of the Director of the Bureau of Legislative Research, is amended to read as follows to reflect that, pursuant to Arkansas Constitution, Article 5, § 29, an appropriation by the General Assembly is limited to one (1) fiscal year:

(C) Establishing new, repealing, or changing any other policies or procedures of the bureau relating to the delivery of services and other matters pertaining to the operation of the bureau, including the ~~biennial~~ annual budget request of the bureau.

SECTION 2. Arkansas Code § 10-3-310(a)(2), concerning compensation of employees of the Legislative Council, is amended to read as follows to reflect that, pursuant to Arkansas Constitution, Article 5, § 29, an appropriation by the General Assembly is limited to one (1) fiscal year:

(2) All other employees of the Legislative Council shall receive



such remuneration as may be provided by the ~~biennial~~ annual appropriations.

SECTION 3. Arkansas Code § 10-3-409(a)(2), concerning compensation of employees of the Legislative Joint Auditing Committee, is amended to read as follows to reflect that, pursuant to Arkansas Constitution, Article 5, § 29, an appropriation by the General Assembly is limited to one (1) fiscal year:

(2) All other employees of the Legislative Joint Auditing Committee shall receive such remuneration as may be provided by the ~~biennial~~ annual appropriations.

SECTION 4. Arkansas Code § 10-3-1402(b), concerning the Office of Economic and Tax Policy, is amended to read as follows to reflect that, pursuant to Arkansas Constitution, Article 5, § 29, an appropriation by the General Assembly is limited to one (1) fiscal year:

(b) The office shall be staffed by such personnel as may be authorized by ~~biennial~~ annual appropriations of the General Assembly.

SECTION 5. Arkansas Code § 10-4-409(a), concerning the employees of the Division of Legislative Audit, is amended to read as follows to reflect that, pursuant to Arkansas Constitution, Article 5, § 29, an appropriation by the General Assembly is limited to one (1) fiscal year:

(a) Subject to a ~~biennial~~ an annual appropriation therefor, all employees of the Division of Legislative Audit shall be selected and appointed by the Legislative Auditor.

SECTION 6. DO NOT CODIFY. The enactment and adoption of this act shall not repeal, expressly or impliedly, the acts passed at the regular session of the Ninetieth General Assembly. All such acts shall have the full force and effect, and so far as those acts intentionally vary from or conflict with any provision contained in this act, those acts shall have the effect of subsequent acts and as amending or repealing the appropriate parts of the Arkansas Code of 1987.
