AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF
HIGHER EDUCATION; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER
EDUCATION REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - ARKANSAS NORTHEASTERN COLLEGE. There is hereby appropriated, to the Arkansas Northeastern College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas Northeastern College the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (F) Section 1 of Act 207 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$175,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (G) Section 1 of Act 207 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$250,000.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 217 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements,



technology upgrades/equipment and library resources of a Workforce Training Building, in a sum not to exceed.....\$2,750,000.

(D) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 1 of Act 217 of 2015, for deferred maintenance, in a sum not to exceed.....\$320,000.

(E) Effective July 1, 2016, the balance of the appropriation provided in Item (C) Section 1 of Act 217 of 2015, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$155,815.

(F) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 522 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$100,000.

SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - BEEBE. There is hereby appropriated, to the Arkansas State University - Beebe, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University - Beebe the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 2 of Act 217 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of an IT Services Data Center, in a sum not to exceed.....\$2,813,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 2 of Act 217 of 2015, for renovations of State Hall, in a sum not to exceed.....\$437,000.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (C) Section 2 of Act 217 of 2015, for deferred maintenance, in a sum not to exceed.....\$980,000.

(D) Effective July 1, 2016, the balance of the appropriation provided in Item (D) Section 2 of Act 217 of 2015, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$488,585.

(E) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 443 of 2015, for construction, renovation, equipment, maintenance, personal services and operating expenses of the ASU - Heber Springs Campus Academic Building, in a sum not to exceed

.....\$20,000.

SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MID-SOUTH.

There is hereby appropriated, to the Arkansas State University - Mid-South, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University - Mid-South the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 10 of Act 207 of 2015, for deferred maintenance, in a sum not to exceed.....\$300,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 9 of Act 217 of 2015, for construction of an Aviation Annex, in a sum not to exceed.....\$2,750,000.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 9 of Act 217 of 2015, for deferred maintenance, in a sum not to exceed.....\$400,000.

(D) Effective July 1, 2016, the balance of the appropriation provided in Item (C) Section 9 of Act 217 of 2015, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$178,465.

SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MOUNTAIN HOME.

There is hereby appropriated, to the Arkansas State University - Mountain Home, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University - Mountain Home the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 3 of Act 217 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of an Occupational Technical Center, in a sum not to exceed.....\$2,000,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 3 of Act 217 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Health and Wellness Center, in a sum not to exceed.....\$750,000.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (C) Section 3 of Act 217 of 2015, for deferred maintenance, in a sum

not to exceed.....\$180,000.

(D) Effective July 1, 2016, the balance of the appropriation provided in Item (D) Section 3 of Act 217 of 2015, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$179,260.

(E) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 784 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$50,000.

SECTION 5. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - NEWPORT.

There is hereby appropriated, to the Arkansas State University - Newport, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University - Newport the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 4 of Act 217 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Multi-Purpose Building on the Jonesboro campus, in a sum not to exceed.....\$2,000,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 4 of Act 217 of 2015, for renovation of the Academic Building on the Jonesboro campus, in a sum not to exceed.....\$750,000.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (C) Section 4 of Act 217 of 2015, for deferred maintenance, in a sum not to exceed.....\$300,000.

(D) Effective July 1, 2016, the balance of the appropriation provided in Item (D) Section 4 of Act 217 of 2015, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$239,545.

(E) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 454 of 2015, for construction, operations, renovation, maintenance, equipment, technology upgrades/equipment of a Workforce Education Program facility, in a sum not to exceed.....\$25,000.

(F) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 462 of 2015, for construction, operations, renovation, maintenance, equipment technology upgrades/equipment of a Workforce Education Program facility, in a sum not to exceed.....\$25,000.

(G) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 480 of 2015, for construction, operations, renovation, maintenance, equipment, and technology upgrades/equipment of the Workforce Education Program facility at the Jonesboro Campus, in a sum not to exceed.....\$30,000.

(H) Effective July 1, 2016, the balance of the appropriation provided in Item (I) Section 4 of Act 214 of 2014, for parking lot renovations, resurfacing, paving, landscaping, painting, operating expenses, equipment, and lighting expenses of the Marked Tree campus, in a sum not to exceed\$100,734.

SECTION 6. REAPPROPRIATION - BLACK RIVER TECHNICAL COLLEGE. There is hereby appropriated, to the Black River Technical College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Black River Technical College the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (E) Section 5 of Act 207 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources at the Pocahontas Campus, in a sum not to exceed.....\$145,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (F) Section 5 of Act 207 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$250,000.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 5 of Act 217 of 2015, for energy efficient lighting upgrades, in a sum not to exceed.....\$500,000.

SECTION 7. REAPPROPRIATION - COLLEGE OF THE OUACHITAS. There is hereby appropriated, to the College of The Ouachitas, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the College of The Ouachitas the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 6 of Act 217 of 2015, for renovation of the Workforce Innovation Center, in a sum not to exceed.....\$300,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 6 of Act 217 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of the Conference and Student Center, in a sum not to exceed.....\$2,200,000.

There is hereby appropriated, to the Cossatot Community College of the University of Arkansas, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Cossatot Community College of the University of Arkansas the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 7 of Act 217 of 2015, for construction, renovation,

maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of the Education Center, in a sum not to exceed.....\$2,750,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 7 of Act 217 of 2015, for deferred maintenance, in a sum not to exceed.....\$280,000.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (C) Section 7 of Act 217 of 2015, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$152,105.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (I) Section 9 of Act 207 of 2015, for construction, renovation maintenance, critical maintenance, equipment, security enhancements,

technology upgrades/equipment and library resources, in a sum not to exceed\$250,000.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 8 of Act 217 of 2015, for technology infrastructure updates, in a sum not to exceed.....\$182,500.

SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL OR TEMPORARY LAW. FUND TRANSFER. Immediately upon the effective date of this Act, the Chief Fiscal Officer of the State shall transfer on her or his books and those of the State Treasurer and the Auditor of State the sum of two hundred sixty-three thousand fifty-six dollars (\$263,056) from the unobligated balance in the 90th Session Projects Account of the General Improvement Fund to the 89th Session Projects Account of the General Improvement Fund to provide funds for reappropriations that were inadvertently discontinued.

SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. As referenced in Section 1(B) of Act 653 of 2013, and Section 3(c) of Act 1518 and 1519 of 2013, the authorized funding for Pulaski Technical College for renovation, maintenance, critical maintenance, equipment, security enhancements and modifications to assure compliance with the Americans With Disabilities Act (ADA) at the Little Rock - West site, shall be deemed to

also include or for renovation, maintenance, critical maintenance, equipment, security enhancements and modifications to assure compliance with the Americans With Disabilities Act (ADA) campus-wide.

SECTION 25. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. (a) As referenced in Section 3(c) of Act 1147 of 2015, the authorized funding for the SAU-Tech for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and furnishings for the Auto Body Shop Building shall be deemed to also include costs of campus safety and technology upgrades and replacement.
(b) As referenced in Section 3(c) of Act 1518 of 2013 and Section 3(c) of Act 1519 of 2013, the authorized funding for the SAU-Tech for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and furnishings for the Auto Body Shop Building shall be deemed to also include costs of campus safety and technology upgrades and replacement.
(c) As referenced in Section 3(c) of Act 1096 of 2011 and Section 3(c) of Act 1117 of 2011, the authorized funding for the SAU-Tech for construction, renovation and equipment for the Auto Body Building shall be deemed to also include costs of campus safety and technology upgrades and replacement.

SECTION 26. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the

Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 27. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 28. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2016 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2016 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2016.
