## For An Act To Be Entitled

AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL  
IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF  
HIGHER EDUCATION; AND FOR OTHER PURPOSES.

## Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER  
EDUCATION REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - HENDERSON STATE UNIVERSITY - GENERAL  
IMPROVEMENT. There is hereby appropriated, to the Henderson State  
University, to be payable from the General Improvement Fund or its successor  
fund or fund accounts, for the Henderson State University the following:

(A) Effective July 1, 2016, the balance of the appropriation provided  
in Item (A) Section 3 of Act 201 of 2015, for Phase I renovation to various  
campus buildings, in a sum not to exceed.....\$3,000,000.

(B) Effective July 1, 2016, the balance of the appropriation provided  
in Item (B) Section 3 of Act 201 of 2015, for construction of a School of  
Business building and renovation of Mooney Hall, in a sum not to  
exceed.....\$2,000,000.

(C) Effective July 1, 2016, the balance of the appropriation provided  
in Item (C) Section 3 of Act 201 of 2015, for upgrade and replacement of  
campus network infrastructure, in a sum not to exceed.....\$1,800,000.

(D) Effective July 1, 2016, the balance of the appropriation provided  
in Item (D) Section 3 of Act 201 of 2015, for furnishings and equipment for  
the Hot Springs Education Center, in a sum not to exceed.....\$200,000.



(E) Effective July 1, 2016, the balance of the appropriation provided in Item (E) Section 3 of Act 201 of 2015, for deferred maintenance, in a sum not to exceed.....\$1,690,000.

(F) Effective July 1, 2016, the balance of the appropriation provided in Item (F) Section 3 of Act 201 of 2015, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed .....\$596,197.

(G) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 248 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$62,500.

SECTION 2. REAPPROPRIATION - HENDERSON STATE UNIVERSITY - TRUST - CADDO CENTER RENOVATIONS. There is hereby appropriated, to the Henderson State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Henderson State University the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (01) Section 29 of Act 718 of 2015, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$747,000.

SECTION 3. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY - GENERAL IMPROVEMENT. There is hereby appropriated, to the Southern Arkansas University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Southern Arkansas University the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 9 of Act 124 of 2015, for expenses of a lignite feasibility study, in a sum not to exceed.....\$32,194.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 9 of Act 124 of 2015, for constructing, equipping, personal services, maintenance and operating expenses of a Natural Resources Research Center for research of lignite and other natural resources in the State, in a sum not to exceed.....\$67,498.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (E) Section 9 of Act 124 of 2015, for deferred maintenance expenses,

in a sum not to exceed.....\$602,824.

(D) Effective July 1, 2016, the balance of the appropriation provided in Item (I) Section 9 of Act 124 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed .....\$140,047.

(E) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 4 of Act 201 of 2015, for constructing and equipping mechanical and electrical engineering laboratories and classrooms, in a sum not to exceed.....\$2,333,950.

(F) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 4 of Act 201 of 2015, for technology infrastructure improvements and upgrades, in a sum not to exceed.....\$2,666,050.

(G) Effective July 1, 2016, the balance of the appropriation provided in Item (C) Section 4 of Act 201 of 2015, for construction of agricultural instructional lab facilities, in a sum not to exceed.....\$1,405,500.

(H) Effective July 1, 2016, the balance of the appropriation provided in Item (D) Section 4 of Act 201 of 2015, for renovation and upgrades to the Science, Technology, Engineering and Mathematics training center, in a sum not to exceed.....\$594,500.

(I) Effective July 1, 2016, the balance of the appropriation provided in Item (E) Section 4 of Act 201 of 2015, for deferred maintenance, in a sum not to exceed.....\$1,660,000.

(J) Effective July 1, 2016, the balance of the appropriation provided in Item (F) Section 4 of Act 201 of 2015, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed .....\$516,183.

SECTION 4. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY - TRUST - OVERSTREET HALL RESTORATION. There is hereby appropriated, to the Southern Arkansas University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Southern Arkansas University the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (01) Section 29 of Act 718 of 2015, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings,

structures or objects, in a sum not to exceed.....\$93,000.

SECTION 5. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - GENERAL IMPROVEMENT. There is hereby appropriated, to the Arkansas State University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 1 of Act 124 of 2015, for construction of a Humanities and Social Sciences Building, in a sum not to exceed.....\$4,000,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (I) Section 1 of Act 124 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$915,458.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 201 of 2015, for renovation of Wilson Hall, in a sum not to exceed.....\$3,000,000.

(D) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 1 of Act 201 of 2015, for construction of a Studio Arts addition to the College of Fine Arts, in a sum not to exceed .....\$3,000,000.

(E) Effective July 1, 2016, the balance of the appropriation provided in Item (C) Section 1 of Act 201 of 2015, for renovation of the International Student Center building, in a sum not to exceed.....\$2,000,000.

(F) Effective July 1, 2016, the balance of the appropriation provided in Item (D) Section 1 of Act 201 of 2015, for deferred maintenance, in a sum not to exceed.....\$4,620,000.

(G) Effective July 1, 2016, the balance of the appropriation provided in Item (E) Section 1 of Act 201 of 2015, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed .....\$2,273,164.

(H) Effective July 1, 2016, the balance of the appropriation provided in Item (F) Section 1 of Act 201 of 2015, for construction, renovation, maintenance, equipment, personal services and operating expenses of the various institutions and entities of the Arkansas State University System, in a sum not to exceed.....\$15,000,000.

(I) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 811 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$500,000.

(J) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 423 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$75,000.

(K) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 755 of 2015, for remodeling, renovation, refurbishing, equipment, furnishings, replacement of plumbing/electrical/heating and cooling systems, and exhibit expenses of Lakeport Plantation facilities, in a sum not to exceed.....\$10,000.

(L) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 767 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources for the Paragould Instructional Site, in a sum not to exceed.....\$5,000.

(M) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 773 of 2015, for major maintenance, construction, operating expenses, security equipment, repairs, and equipment for the Hemingway-Pfeiffer Museum and Educational Center, in a sum not to exceed.....\$15,000.

(N) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 775 of 2015, for capital improvements including completion of theatre reconstruction, parking and landscaping at Colony Center, adjacent outdoor stage, parking at Cash home, construction of outbuildings, including barn for classrooms and restrooms, and colony house to be used for security/maintenance, in a sum not to exceed.....\$75,000.

SECTION 6. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - TRUST - DYESS COLONY THEATRE. There is hereby appropriated, to the Arkansas State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas State University the

following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (01) Section 29 of Act 718 of 2015, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$486,000.

SECTION 7. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY - GENERAL IMPROVEMENT. There is hereby appropriated, to the Arkansas Tech University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas Tech University the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 2 of Act 201 of 2015, for construction of an Academic Classroom Facility, in a sum not to exceed.....\$3,000,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (B) Section 2 of Act 201 of 2015, for the provision of Instructional Technology on the Ozark Campus, in a sum not to exceed.....\$177,713.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (C) Section 2 of Act 201 of 2015, for replacement of the Technology and Academic Support building roof on the Ozark Campus, in a sum not to exceed.....\$787,549.

(D) Effective July 1, 2016, the balance of the appropriation provided in Item (D) Section 2 of Act 201 of 2015, for technology infrastructure improvements and upgrades, in a sum not to exceed.....\$2,500,000.

(E) Effective July 1, 2016, the balance of the appropriation provided in Item (E) Section 2 of Act 201 of 2015, for renovation and critical maintenance of educational and general buildings, in a sum not to exceed.....\$2,000,000.

(F) Effective July 1, 2016, the balance of the appropriation provided in Item (F) Section 2 of Act 201 of 2015, for deferred maintenance at the Ozark Campus, in a sum not to exceed.....\$180,000.

(G) Effective July 1, 2016, the balance of the appropriation provided in Item (G) Section 2 of Act 201 of 2015, for purchase, replacement, and renewal of equipment and library holdings at the Ozark Campus, in a sum not to exceed.....\$160,150.

(H) Effective July 1, 2016, the balance of the appropriation provided in Item (H) Section 2 of Act 201 of 2015, for deferred maintenance, in a sum

not to exceed.....\$2,120,000.

(I) Effective July 1, 2016, the balance of the appropriation provided in Item (I) Section 2 of Act 201 of 2015, for purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed .....\$1,318,855.

(J) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 493 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$142,500.

SECTION 8. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY - TRUST - WILSON HALL RENOVATION. There is hereby appropriated, to the Arkansas Tech University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas Tech University the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (01) Section 29 of Act 718 of 2015, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$1,000,000.

SECTION 9. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FAYETTEVILLE - GENERAL IMPROVEMENT. There is hereby appropriated, to the University of Arkansas, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (BB) Section 13 of Act 124 of 2015, for personal services and general operating expenses of the Partners for Inclusive Communities - Sickle Cell Anemia Task Force, in a sum not to exceed.....\$60,000.

(B) Effective July 1, 2016, the balance of the appropriation provided in Item (S) Section 13 of Act 124 of 2015, for Nanoscale Material Science and Engineering building construction, in a sum not to exceed.....\$2,774,142.

(C) Effective July 1, 2016, the balance of the appropriation provided in Item (Y) Section 13 of Act 124 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$275,228.

(D) Effective July 1, 2016, the balance of the appropriation provided in Item (Z) Section 13 of Act 124 of 2015, for construction, equipment, maintenance, deferred maintenance, renovation, personal services and operating expenses of the Criminal Justice Institute, in a sum not to exceed.....\$6,800.

(V) Effective July 1, 2016, the balance of the appropriation provided

(W) Effective July 1, 2016, the balance of the appropriation provided in Item (S) Section 6 of Act 201 of 2015, for costs of constructing and equipping a Food Innovation Center of the Division of Agriculture, in a sum not to exceed.....\$300,000.

(X) Effective July 1, 2016, the balance of the appropriation provided in Item (T) Section 6 of Act 201 of 2015, for deferred maintenance of the Division of Agriculture, in a sum not to exceed.....\$1,510,000.

(Y) Effective July 1, 2016, the balance of the appropriation provided in Item (U) Section 6 of Act 201 of 2015, for construction, renovation, maintenance, equipment, personal services and operating expenses of the various institutions and entities of the University of Arkansas System, in a sum not to exceed.....\$15,000,000.

(Z) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 252 of 2015, for personal services and operating expenses in support of providing a positive 4-H youth development experience for Arkansas youth between the ages of 5 and 19, in a sum not to exceed.....\$10,000.

(AA) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 461 of 2015, for renovation, maintenance, personal services, equipment, and operational expenses of the Arkansas Archeological Survey, in a sum not to exceed.....\$10,000.

(BB) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 494 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, personal services, operating expenses, technology upgrades/equipment and library resources of the Arkansas School for Mathematics, Sciences and the Arts, in a sum not to exceed.....\$25,000.

(CC) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 518 of 2015, for personal services and general operating expenses, construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources for U of A - Fayetteville - Partners for Inclusive Communities, in a sum not to exceed.....\$50,000.

(DD) Effective July 1, 2016, the balance of the appropriation provided

in Item (A) Section 1 of Act 521 of 2015, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, and technology upgrades/equipment for U of A - Garvan Woodland Gardens, in a sum not to exceed.....\$100,000.

(EE) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 656 of 2015, for U of A Fayetteville Partners for Inclusive Communities Autism Awareness Supporting Grants, in a sum not to exceed.....\$50,000.

(FF) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 661 of 2015, for scholarships, operations, equipment, improvements, and renovations for the Clinton School of Public Service, in a sum not to exceed.....\$75,000.

(GG) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 667 of 2015, for personal services and general operating expenses, construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources for the U of A - Fayetteville - Pryor Center for Oral and Visual History, in a sum not to exceed.....\$10,000.

(HH) Effective July 1, 2016, the balance of the appropriation provided in Item (A) Section 1 of Act 776 of 2015, for transfer of funds and appropriation by the President of the University of Arkansas to the various institutions and entities of the University of Arkansas System for construction, renovation, maintenance, equipment, personal services, and operating expenses, in a sum not to exceed.....\$20,000,000.

in Item (01) Section 29 of Act 718 of 2015, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$44,133.

SECTION 11. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FAYETTEVILLE - TRUST - SITE DATA AUTOMATED MANAGEMENT. There is hereby appropriated, to the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (01) Section 29 of Act 718 of 2015, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$20,396.

SECTION 12. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FAYETTEVILLE - TRUST - BLUFF SHELTERS PRESERVATION & INTERPRETATION. There is hereby appropriated, to the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas the following:

(A) Effective July 1, 2016, the balance of the appropriation provided in Item (01) Section 29 of Act 718 of 2015, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$35,471.

SECTION 26. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 27. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 28. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the

effectiveness of this Act on July 1, 2016 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2016 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2016.
