21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. Arkansas Code § 11-10-706(f)(2), concerning the
24 stabilization tax for the Department of Workforce Services Law, is amended to
25 read as follows:

26 (2)(A) However, the proceeds of the stabilization tax in the amount of
27 two and one-half hundredths of one percent (.025%) of taxable wages collected
28 during the period July 1, 2007, through June 30, 2019, shall be deposited and
29 credited to the Department of Workforce Services Unemployment Insurance
30 Administration Fund, there to be used for personal services and operating
31 expenses of the unemployment insurance program necessary for the proper
32 administration of the Department of Workforce Services Law, § 11-10-101 et
33 seq., as determined by the Director of the Department of Workforce Services.

34 (B)(i) The total amount deposited into the Department of
35 Workforce Services Unemployment Insurance Administration Fund in any one (1)
36 fiscal year shall not exceed two million five hundred thousand dollars



1 (\$2,500,000).

2 (ii) If the amount deposited into the Department of
3 Workforce Services Unemployment Insurance Administration Fund under
4 subdivision (f)(2)(B)(i) of this section is not sufficient to the meet the
5 administrative needs of the department, the Chief Fiscal Officer of the State
6 may transfer up to an additional three million five hundred thousand dollars
7 (\$3,500,000) in any one (1) fiscal year to the Department of Workforce
8 Services Unemployment Insurance Administration Fund.

10 SECTION 2. Arkansas Code § 19-5-1232(b)(2), concerning the Department
11 of Workforce Services Unemployment Insurance Administration Fund, is amended
12 to read as follows:

13 (2) The fund shall be used for personal services and operating
14 expenses of the unemployment insurance program necessary to the proper
15 administration of the Department of Workforce Services Law, § 11-10-101 et
16 seq., as determined by the Director of the Department of Workforce Services.
