## For An Act To Be Entitled

AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND OPERATING EXPENSES FOR THE COMMISSIONER OF STATE LANDS AND FOR DISTRIBUTING PROCEEDS FROM THE SALE OR REDEMPTION OF TAX DELINQUENT LAND FOR THE FISCAL YEAR ENDING JUNE 30, 2019; AND FOR OTHER PURPOSES.

## Subtitle

AN ACT FOR THE COMMISSIONER OF STATE LANDS APPROPRIATION FOR THE 2018-2019 FISCAL YEAR.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established for the Commissioner of State Lands for the 2018-2019 fiscal year, the following maximum number of regular employees.

SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for the Commissioner of State Lands for the 2018-2019 fiscal year, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: five (5) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.

SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated, to the Commissioner of State Lands, to be payable from the State Central Services Fund, for personal services and operating expenses of the Commissioner of State Lands for the fiscal year ending June 30, 2019, the following:

SECTION 4. APPROPRIATION - DELINQUENT TAX. There is hereby appropriated, to the Commissioner of State Lands, to be payable from cash funds as defined by Arkansas Code 19-4-801 of the Commissioner of State Lands, for operating expenses and for distributing proceeds from the sale or redemption of tax delinquent land as prescribed by Chapter 37 of Title 26 of the Arkansas Code by the Commissioner of State Lands for the fiscal year ending June 30, 2019, the following:

SECTION 5. APPROPRIATION - CAPITAL OUTLAY/OPERATING EXPENSES. There is hereby appropriated, to the Commissioner of State Lands, to be payable from cash funds as defined by Arkansas Code 19-4-801 of the Commissioner of State Lands, from proceeds of fees collected by the Commissioner of State Lands, for operating expenses and capital outlay of the Commissioner of State Lands for the fiscal year ending June 30, 2019, the following:

SECTION 6. APPROPRIATION - ADOPT A DOCUMENT PROGRAM. There is hereby appropriated, to the Commissioner of State Lands, to be payable from cash funds as defined by Arkansas Code 19-4-801 of the Commissioner of State Lands, for personal services and operating expenses for the Adopt a Document Program administered by the Commissioner of State Lands for the fiscal year ending June 30, 2019, the following:

SECTION 7. APPROPRIATION - SUBMERGED LANDS. There is hereby appropriated, to the Commissioner of State Lands, to be payable from cash funds as defined by Arkansas Code 19-4-801 of the Commissioner of State Lands, for personal services and operating expenses for projects involving submerged land by the Commissioner of State Lands for the fiscal year ending June 30, 2019, the following:

SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 9. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 10. EFFECTIVE DATE. This act is effective on and after July 1, 2018.
