AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES
AND OPERATING EXPENSES FOR THE ARKANSAS HOME
INSPECTOR REGISTRATION BOARD FOR THE FISCAL YEAR
ENDING JUNE 30, 2019; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE ARKANSAS HOME INSPECTOR
REGISTRATION BOARD APPROPRIATION FOR THE
2018-2019 FISCAL YEAR.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REGULAR SALARIES. There is hereby established for the
Arkansas Home Inspector Registration Board for the 2018-2019 fiscal year, the
following maximum number of regular employees.

SECTION 2. APPROPRIATION - OPERATIONS. There is hereby appropriated,
to the Arkansas Home Inspector Registration Board, to be payable from the
Arkansas Home Inspectors Registration Fund, for personal services and
operating expenses of the Arkansas Home Inspector Registration Board for the



fiscal year ending June 30, 2019, the following:

SECTION 3. APPROPRIATION - PUBLIC AWARENESS CAMPAIGN. There is hereby appropriated, to the Arkansas Home Inspector Registration Board, to be payable from the Arkansas Home Inspectors Registration Fund, for the research, procurement, and implementation of a public awareness campaign of the Arkansas Home Inspector Registration Board for the fiscal year ending June 30, 2019, the following:

SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 5. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget

manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 6. EFFECTIVE DATE. This act is effective on and after July 1, 2018.
