20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
23 for the Arkansas State Board of Dental Examiners for the 2019-2020 fiscal
24 year, the following maximum number of regular employees.

35 SECTION 2. APPROPRIATION - OPERATIONS. There is hereby appropriated,
36 to the Arkansas State Board of Dental Examiners, to be payable from the cash

1 fund deposited in the State Treasury as determined by the Chief Fiscal
 2 Officer of the State, for personal services and operating expenses of the
 3 Arkansas State Board of Dental Examiners for the fiscal year ending June 30,
 4 2020, the following:

 19 SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS
 21 STATE DENTAL EXAMINERS BOARD EMPLOYMENT OF ATTORNEYS. None of the funds
 22 appropriated in this Act for Maintenance and General Operation shall be
 23 expended in payment for services of attorneys, unless the agency shall first
 24 make a request in writing to the Attorney General of the State of Arkansas to
 25 provide the required legal services. The Attorney General's Office shall
 26 provide the requested legal services, or, if the Attorney General's Office
 27 shall determine that sufficient personnel are not available to provide the
 28 requested legal services, the Attorney General shall certify the same to the
 29 agency and may authorize the agency to employ legal counsel and to expend
 30 monies appropriated for Maintenance and General Operations therefore, if:

- 31 (1) The Attorney General determines, and certifies in writing, that such
 32 agency needs the advice or assistance of legal counsel, and
- 33 (2) The Attorney General consents in writing to the employment of the
 34 legal counsel to be retained by the agency, and
- 35 (3) The Attorney General receives confirmation in writing from the Agency
 36 that the agency will re-advertise annually for legal counsel if outside legal

1 counsel is hired and that any amount to be paid for outside legal counsel
2 will be reviewed and approved by the Arkansas Legislative Council or Joint
3 Budget Committee.

4 Such certification shall be required with respect to each instance of the
5 employment of special legal counsel, or shall be required annually with
6 respect to legal counsel employed on a retainer basis. A copy of such
7 certification shall be entered in the official minutes of the agency, and
8 shall be retained in the fiscal records of the agency for audit purposes.

9 The provisions of this section shall be in effect only from July 1, ~~2018~~
10 2019 through June 30, ~~2019~~ 2020.

11
12 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
13 authorized by this act shall be limited to the appropriation for such agency
14 and funds made available by law for the support of such appropriations; and
15 the restrictions of the State Procurement Law, the General Accounting and
16 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
17 Procedures and Restrictions Act, or their successors, and other fiscal
18 control laws of this State, where applicable, and regulations promulgated by
19 the Department of Finance and Administration, as authorized by law, shall be
20 strictly complied with in disbursement of said funds.

21
22 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General
23 Assembly that any funds disbursed under the authority of the appropriations
24 contained in this act shall be in compliance with the stated reasons for
25 which this act was adopted, as evidenced by the Agency Requests, Executive
26 Recommendations and Legislative Recommendations contained in the budget
27 manuals prepared by the Department of Finance and Administration, letters, or
28 summarized oral testimony in the official minutes of the Arkansas Legislative
29 Council or Joint Budget Committee which relate to its passage and adoption.

30
31 SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General
32 Assembly, that the Constitution of the State of Arkansas prohibits the
33 appropriation of funds for more than a one (1) year period; that the
34 effectiveness of this Act on July 1, 2019 is essential to the operation of
35 the agency for which the appropriations in this Act are provided, and that in
36 the event of an extension of the legislative session, the delay in the

effective date of this Act beyond July 1, 2019 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2019.
