11 YEAR ENDING JUNE 30, 2020; AND FOR OTHER PURPOSES.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. REGULAR SALARIES. There is hereby established for the  
24 Arkansas Commission on Law Enforcement Standards and Training for the 2019-  
25 2020 fiscal year, the following maximum number of regular employees.

1 hereby appropriated, to the Arkansas Commission on Law Enforcement Standards  
 2 and Training, to be payable from the Fallen Law Enforcement Officers'  
 3 Beneficiary Fund, for personal services, operating expenses and grants to  
 4 provide support and assistance to beneficiaries of fallen law enforcement  
 5 officers of the Arkansas Commission on Law Enforcement Standards and Training  
 6 - Fallen Law Enforcement Officers for the fiscal year ending June 30, 2020,  
 7 the following:

 13 SECTION 6. APPROPRIATION - FALLEN LAW ENFORCEMENT OFFICERS. There is  
 14 hereby appropriated, to the Arkansas Commission on Law Enforcement Standards  
 15 and Training, to be payable from the Miscellaneous Agencies Fund Account, for  
 16 personal services, operating expenses and grants to provide support and  
 17 assistance to beneficiaries of fallen law enforcement officers of the  
 18 Arkansas Commission on Law Enforcement Standards and Training - Fallen Law  
 19 Enforcement Officers for the fiscal year ending June 30, 2020, the following:

 25 SECTION 7. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 26 authorized by this act shall be limited to the appropriation for such agency  
 27 and funds made available by law for the support of such appropriations; and  
 28 the restrictions of the State Procurement Law, the General Accounting and  
 29 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 30 Procedures and Restrictions Act, or their successors, and other fiscal  
 31 control laws of this State, where applicable, and regulations promulgated by  
 32 the Department of Finance and Administration, as authorized by law, shall be  
 33 strictly complied with in disbursement of said funds.

34  
 35 SECTION 8. LEGISLATIVE INTENT. It is the intent of the General  
 36 Assembly that any funds disbursed under the authority of the appropriations

1 contained in this act shall be in compliance with the stated reasons for  
2 which this act was adopted, as evidenced by the Agency Requests, Executive  
3 Recommendations and Legislative Recommendations contained in the budget  
4 manuals prepared by the Department of Finance and Administration, letters, or  
5 summarized oral testimony in the official minutes of the Arkansas Legislative  
6 Council or Joint Budget Committee which relate to its passage and adoption.  
7

8 SECTION 9. EMERGENCY CLAUSE. It is found and determined by the General  
9 Assembly, that the Constitution of the State of Arkansas prohibits the  
10 appropriation of funds for more than a one (1) year period; that the  
11 effectiveness of this Act on July 1, 2019 is essential to the operation of  
12 the agency for which the appropriations in this Act are provided, and that in  
13 the event of an extension of the legislative session, the delay in the  
14 effective date of this Act beyond July 1, 2019 could work irreparable harm  
15 upon the proper administration and provision of essential governmental  
16 programs. Therefore, an emergency is hereby declared to exist and this Act  
17 being necessary for the immediate preservation of the public peace, health  
18 and safety shall be in full force and effect from and after July 1, 2019.
