## Subtitle

TO INCREASE ANNUAL FEES FOR ISSUANCE OF  
LICENSURE FOR CERTAIN HEALTHCARE  
FACILITIES LICENSED BY THE DEPARTMENT OF  
HEALTH.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code § 20-9-214(b), concerning fees for issuance of licensure by the Department of Health, is amended to read as follows:

(b) The Department of Health may levy and collect the following annual fees for issuance of an annual license to ~~hospitals or institutions~~ a hospital or institution per facility, unless otherwise noted:
