PURPOSES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code § 19-4-906(a)(060), concerning the maximum
authorized number of passenger motor vehicles, is amended to read as follows:
(060) Arkansas State University – Newport ~~21~~ 26

SECTION 2. Arkansas Code § 19-4-906(a)(093), concerning the maximum
authorized number of passenger motor vehicles, is amended to read as follows:
(093) East Arkansas Community College ~~13~~ 28

SECTION 3. Arkansas Code § 19-4-906(a)(098), concerning the maximum
authorized number of passenger motor vehicles, is amended to read as follows:
(098) Arkansas State University Mid-South ~~15~~ 20

SECTION 4. Arkansas Code § 19-4-906(a)(101), concerning the maximum



authorized number of passenger motor vehicles, is amended to read as follows:
(101) Northwest Arkansas Community College ~~20~~ 22

SECTION 5. Arkansas Code § 19-4-906(a)(109), concerning the maximum authorized number of passenger motor vehicles, is amended to read as follows:
(109) University of Arkansas Community College at Rich Mountain ~~12~~ 15

SECTION 6. Arkansas Code § 19-4-906(a)(115), concerning the maximum authorized number of passenger motor vehicles, is amended to read as follows:
(115) Southern Arkansas University – Magnolia ~~46~~ 50

SECTION 7. Arkansas Code § 19-4-906(a)(129), concerning the maximum authorized number of passenger motor vehicles, is amended to read as follows:
(129) University of Arkansas at Fayetteville ~~605~~ 299

SECTION 8. Arkansas Code § 19-4-906(a)(137), concerning the maximum authorized number of passenger motor vehicles, is amended to read as follows:
(137) University of Arkansas for Medical Sciences ~~105~~ 110

SECTION 9. Arkansas Code § 19-4-906(a), concerning the maximum authorized number of passenger motor vehicles, is amended to add an additional subdivision to read as follows:
(143) University of Arkansas at Fayetteville – Division of Agriculture

SECTION 10. EMERGENCY CLAUSE. It is found and determined by the General Assembly of the State of Arkansas that changes to the maximum number of motor vehicles authorized for certain institutions of higher education are necessary to maintain the efficient operations of the institutions of higher education; and that the changes in the maximum number of motor vehicles authorized for these institutions of higher education should take effect at the beginning of a fiscal year to maximize the effectiveness and efficiency of the changes in the law. Therefore, an emergency is declared to exist, and this act being necessary for the preservation of the public peace, health, and safety shall become effective on July 1, 2019.
