SENATE BILL 15

## For An Act To Be Entitled

AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL  
IMPROVEMENT APPROPRIATIONS FOR THE DEPARTMENT OF  
HUMAN SERVICES - DIVISION OF AGING, ADULT, AND  
BEHAVIORAL HEALTH SERVICES; AND FOR OTHER PURPOSES.

### Subtitle

AN ACT FOR THE DEPARTMENT OF HUMAN  
SERVICES - DIVISION OF AGING, ADULT, AND  
BEHAVIORAL HEALTH SERVICES  
REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - DIVISION OF AGING, ADULT, AND BEHAVIORAL  
HEALTH SERVICES. There is hereby appropriated, to the Department of Human  
Services, to be payable from the Development and Enhancement Fund, for the  
Department of Human Services - Division of Aging, Adult, and Behavioral  
Health Services the following:

(A) Effective July 1, 2020, the balance of the appropriation provided  
in Item (A) of Section 1 of Act 406 of 2019, for replacement of patient  
furnishings at the Arkansas State Hospital, in a sum not to exceed ..\$76,000.

(B) Effective July 1, 2020, the balance of the appropriation provided  
in Item (B) of Section 1 of Act 406 of 2019, for replacement of kitchen  
appliances and equipment at the Arkansas State Hospital, in a sum not to  
exceed .....\$51,000.

(C) Effective July 1, 2020, the balance of the appropriation provided  
in Item (C) of Section 1 of Act 406 of 2019, for replacement of exterior



awnings at the Arkansas State Hospital, in a sum not to exceed .....\$50,000.

(D) Effective July 1, 2020, the balance of the appropriation provided in Item (D) of Section 1 of Act 406 of 2019, for replacement of generators and electrical materials and equipment at the Arkansas Health Center, in a sum not to exceed .....\$800,000.

(E) Effective July 1, 2020, the balance of the appropriation provided in Item (E) of Section 1 of Act 406 of 2019, for costs associated with construction, replacement, renovation, upgrade, and addition of a warehouse distribution building for the Arkansas Health Center, in a sum not to exceed .....\$1,500,000.

(F) Effective July 1, 2020, the balance of the appropriation provided in Item (F) of Section 1 of Act 406 of 2019, for replacement of the Arkansas Health Center shuttlebus, in a sum not to exceed .....\$200,000.

SECTION 2. REAPPROPRIATION - DIVISION OF AGING, ADULT, AND BEHAVIORAL HEALTH SERVICES RENOVATION FUND. There is hereby appropriated, to the Department of Human Services, to be payable from the Department of Human Services Renovation Fund, for the Department of Human Services - Division of Aging, Adult, and Behavioral Health Services the following:

(A) Effective July 1, 2020, the balance of the appropriation provided in Item (A) of Section 2 of Act 406 of 2019, for costs associated with construction, replacement, renovation, upgrade, and addition of a warehouse distribution building for the Arkansas Health Center, in a sum not to exceed .....\$2,000,000.

(B) Effective July 1, 2020, the balance of the appropriation provided in Item (B) of Section 2 of Act 406 of 2019, for repair or replacement of roofs at the Arkansas State Hospital, in a sum not to exceed .....\$1,175,065.

SECTION 3. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects

enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 4. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2020 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2020 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2020.
