AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF
HIGHER EDUCATION; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER
EDUCATION REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - ARKANSAS NORTHEASTERN COLLEGE. There is hereby appropriated, to the Arkansas Northeastern College, to be payable from the Development and Enhancement Fund, for the Arkansas Northeastern College the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 1 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Center for Science and Technology, in a sum not to exceed\$1,850,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 1 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$290,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 1 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$390,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 1 of Act 5 of 2020, for repair or replacement of



equipment and library holdings, in a sum not to exceed\$140,140.

SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - BEEBE. There is hereby appropriated, to the Arkansas State University - Beebe, to be payable from the Development and Enhancement Fund, for the Arkansas State University - Beebe the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 2 of Act 5 of 2020, for renovations of State Hall, in a sum not to exceed\$1,375,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 2 of Act 5 of 2020, for renovations of Owen Center, in a sum not to exceed\$2,000,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 2 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$120,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 2 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$1,050,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 2 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$412,685.

SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MID-SOUTH. There is hereby appropriated, to the Arkansas State University - Mid-South, to be payable from the Development and Enhancement Fund, for the Arkansas State University - Mid-South the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 3 of Act 5 of 2020, for upgrade and replacement of Classroom Instructional Technology Equipment, in a sum not to exceed\$100,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 3 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$180,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 3 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$470,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 3 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$140,250.

SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MOUNTAIN HOME. There is hereby appropriated, to the Arkansas State University - Mountain Home, to be payable from the Development and Enhancement Fund, for the Arkansas State University - Mountain Home the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 4 of Act 5 of 2020, for replacing critical maintenance equipment, in a sum not to exceed\$1,000,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 4 of Act 5 of 2020, for acquisition and renovation of an Occupational Technical Center, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 4 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Health and Wellness Center, in a sum not to exceed\$850,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 4 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$260,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 4 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$147,040.

SECTION 5. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - NEWPORT. There is hereby appropriated, to the Arkansas State University - Newport, to be payable from the Development and Enhancement Fund, for the Arkansas State University - Newport the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 5 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Classroom/Student Services Building on the Jonesboro Campus, in a sum not to exceed\$1,000,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 5 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of an Administration Building on the Newport Campus, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 5 of Act 5 of 2020, for renovation and remodel of the Main Building on the Jonesboro Campus, in a sum not to exceed\$850,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 5 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$350,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 5 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$279,520.

SECTION 6. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY THREE RIVERS.

There is hereby appropriated, to the Arkansas State University Three Rivers, to be payable from the Development and Enhancement Fund, for the Arkansas State University Three Rivers the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 7 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of the Health/Science Technology Building, in a sum not to exceed\$1,850,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 7 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of the Conference and Student Center, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 7 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$210,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 7 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$117,495.

SECTION 7. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY THREE RIVERS - RITZ THEATRE. There is hereby appropriated, to the Arkansas State University Three Rivers, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas State University Three Rivers the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$663,263.

SECTION 8. REAPPROPRIATION - BLACK RIVER TECHNICAL COLLEGE. There is hereby appropriated, to the Black River Technical College, to be payable from the Development and Enhancement Fund, for the Black River Technical College the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 6 of Act 5 of 2020, for the renovation of the "A" and "B" Buildings, in a sum not to exceed\$157,500.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 6 of Act 5 of 2020, for the construction of a storage building for Fire Science Program truck and equipment, in a sum not to exceed\$157,500.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 6 of Act 5 of 2020, for equipment replacement in the Academic Complex/Library, in a sum not to exceed\$54,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 6 of Act 5 of 2020, for construction of a storage building for Grounds Maintenance tractors and equipment, in a sum not to exceed\$90,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 6 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Technical Education Building, in a sum not to exceed\$2,319,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 6 of Act 5 of 2020, for heating, ventilation, and air conditioning replacement in the "B" Building, in a sum not to exceed

.....\$72,000.

(G) Effective July 1, 2021, the balance of the appropriation provided in Item (G) of Section 6 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$20,000.

(H) Effective July 1, 2021, the balance of the appropriation provided in Item (H) of Section 6 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$400,000.

(I) Effective July 1, 2021, the balance of the appropriation provided in Item (I) of Section 6 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$184,330.

SECTION 9. REAPPROPRIATION - COSSATOT COMMUNITY COLLEGE OF THE UNIVERSITY OF ARKANSAS. There is hereby appropriated, to the Cossatot Community College of the University of Arkansas, to be payable from the Development and Enhancement Fund, for the Cossatot Community College of the University of Arkansas the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 8 of Act 5 of 2020, for upgrades to network technology infrastructure, in a sum not to exceed\$600,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 8 of Act 5 of 2020, for disaster recovery/business continuity technology infrastructure, in a sum not to exceed\$60,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 8 of Act 5 of 2020, for generator/backup power source technology infrastructure, in a sum not to exceed\$40,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 8 of Act 5 of 2020, for maintenance related to heating, ventilation, and air conditioning for building system failure, in a sum not to exceed\$60,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 8 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$50,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 8 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$255,234.

(G) Effective July 1, 2021, the balance of the appropriation provided

in Item (G) of Section 8 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$136,975.

SECTION 10. REAPPROPRIATION - COSSATOT COMMUNITY COLLEGE OF THE UNIVERSITY OF ARKANSAS - LOCKESBURG MIDDLE SCHOOL RESTORATION. There is hereby appropriated, to the Cossatot Community College of the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Cossatot Community College of the University of Arkansas the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$336,525.

SECTION 11. REAPPROPRIATION - EAST ARKANSAS COMMUNITY COLLEGE. There is hereby appropriated, to the East Arkansas Community College, to be payable from the Development and Enhancement Fund, for the East Arkansas Community College the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 9 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$250,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 9 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$150,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 9 of Act 5 of 2020, for transfers of or refund to expenditures for capital balances for construction, renovation, major maintenance, and purchase of equipment for various capital projects or facility improvements, in a sum not to exceed\$390,591.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 9 of Act 5 of 2020, for renovation of technology infrastructure and systems, in a sum not to exceed\$363,500.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 9 of Act 5 of 2020, for renovation and expansion of

the Maintenance Building, in a sum not to exceed\$280,950.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 9 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of the Student Center, in a sum not to exceed\$1,250,000.

(G) Effective July 1, 2021, the balance of the appropriation provided in Item (G) of Section 9 of Act 5 of 2020, for renovation of Classroom Building 3, in a sum not to exceed\$455,550.

(H) Effective July 1, 2021, the balance of the appropriation provided in Item (H) of Section 9 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$430,000.

(I) Effective July 1, 2021, the balance of the appropriation provided in Item (I) of Section 9 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$97,355.

SECTION 12. REAPPROPRIATION - NATIONAL PARK COLLEGE. There is hereby appropriated, to the National Park College, to be payable from the Development and Enhancement Fund, for the National Park College the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 10 of Act 5 of 2020, for classroom technology upgrades, in a sum not to exceed\$734,400.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 10 of Act 5 of 2020, for upgrades to technology infrastructure, in a sum not to exceed\$1,591,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 10 of Act 5 of 2020, for renovation of the Gerald Fisher Center, in a sum not to exceed\$1,049,600.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 10 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$110,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 10 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$470,000.

(F) Effective July 1, 2021, the balance of the appropriation provided

in Item (F) of Section 10 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$275,650.

SECTION 13. REAPPROPRIATION - NORTH ARKANSAS COLLEGE. There is hereby appropriated, to the North Arkansas College, to be payable from the Development and Enhancement Fund, for the North Arkansas College the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 11 of Act 5 of 2020, for construction, renovation, equipment, acquisition, furnishing, personal services, maintenance and operations expenses of the Searcy County campuses, in a sum not to exceed\$23,800.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 11 of Act 5 of 2020, for renovation and replacement of sliding glass doors, in a sum not to exceed\$100,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 11 of Act 5 of 2020, for renovation of tiered classrooms to comply with the Americans with Disabilities Act, in a sum not to exceed\$75,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 11 of Act 5 of 2020, for public address system technology, in a sum not to exceed\$60,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 11 of Act 5 of 2020, for renovation of Center Campus windows, in a sum not to exceed\$75,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 11 of Act 5 of 2020, for renovation of heating, ventilation, and air conditioning in the Science Building, in a sum not to exceed\$262,437.

(G) Effective July 1, 2021, the balance of the appropriation provided in Item (G) of Section 11 of Act 5 of 2020, for renovation of the South Campus Library, in a sum not to exceed\$1,403,000.

(H) Effective July 1, 2021, the balance of the appropriation provided in Item (H) of Section 11 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$90,000.

(I) Effective July 1, 2021, the balance of the appropriation provided

in Item (I) of Section 11 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$470,000.

(J) Effective July 1, 2021, the balance of the appropriation provided in Item (J) of Section 11 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$200,875.

SECTION 14. REAPPROPRIATION - NORTHWEST ARKANSAS COMMUNITY COLLEGE.

There is hereby appropriated, to the Northwest Arkansas Community College, to be payable from the Development and Enhancement Fund, for the Northwest Arkansas Community College the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 12 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of the Washington County Center, in a sum not to exceed\$1,000,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 12 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of the new Physical Plant facility, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 12 of Act 5 of 2020, for purchase of the former railroad property, in a sum not to exceed\$621,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 12 of Act 5 of 2020, for the construction of storm drainage, leveling and replanting for the grounds covered by the railroad spur after removal, in a sum not to exceed\$190,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 12 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, and technology upgrades/equipment of the NCPTC Generator, in a sum not to exceed\$148,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 12 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$530,000.

(G) Effective July 1, 2021, the balance of the appropriation provided

in Item (G) of Section 12 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$750,145.

SECTION 15. REAPPROPRIATION - OZARKA COLLEGE. There is hereby appropriated, to the Ozarka College, to be payable from the Development and Enhancement Fund, for the Ozarka College the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 13 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Workforce Training Center, in a sum not to exceed\$1,850,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 13 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of an Information Technology Center, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 13 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$10,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 13 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$250,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 13 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$120,615.

SECTION 16. REAPPROPRIATION - PHILLIPS COMMUNITY COLLEGE OF THE UNIVERSITY OF ARKANSAS. There is hereby appropriated, to the Phillips Community College of the University of Arkansas, to be payable from the Development and Enhancement Fund, for the Phillips Community College of the University of Arkansas the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 14 of Act 5 of 2020, for campus security upgrades, in a sum not to exceed\$100,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 14 of Act 5 of 2020, for Americans with Disabilities

Act improvements to various buildings on the Helena-West Helena Campus, in a sum not to exceed\$280,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 14 of Act 5 of 2020, for roof repair or roof replacement for four (4) buildings on the Helena-West Helena Campus and the Training Center - Dewitt Campus, in a sum not to exceed\$1,000,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 14 of Act 5 of 2020, for renovation of the gymnasium on the Helena-West Helena Campus, in a sum not to exceed\$250,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 14 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$140,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 14 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$900,000.

(G) Effective July 1, 2021, the balance of the appropriation provided in Item (G) of Section 14 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$142,430.

SECTION 17. REAPPROPRIATION - PHILLIPS COMMUNITY COLLEGE OF THE UNIVERSITY OF ARKANSAS - PILLOW-THOMPSON HOUSE. There is hereby appropriated, to the Phillips Community College of the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Phillips Community College of the University of Arkansas the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$418,349.

SECTION 18. REAPPROPRIATION - SOUTH ARKANSAS COMMUNITY COLLEGE. There is hereby appropriated, to the South Arkansas Community College, to be payable from the Development and Enhancement Fund, for the South Arkansas Community College the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 15 of Act 5 of 2020, for renovation of the Computer

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 15 of Act 5 of 2020, for renovation of the Career Technical Education Building, in a sum not to exceed\$450,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 15 of Act 5 of 2020, for technology infrastructure upgrades, in a sum not to exceed\$425,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 15 of Act 5 of 2020, for an addition to the Health and Natural Sciences Building, in a sum not to exceed\$772,158.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 15 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$50,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 15 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$450,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 17 of Act 5 of 2020, for replacement of the College Hall North Roof, in a sum not to exceed\$35,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 17 of Act 5 of 2020, for replacement of transformers at General Studies South, in a sum not to exceed\$25,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 18 of Act 5 of 2020, for technology infrastructure upgrades, in a sum not to exceed\$700,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 18 of Act 5 of 2020, for upgrades and replacement of heating, ventilation, and air conditioning equipment, in a sum not to exceed\$422,047.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 18 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$280,000.

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 19 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a dormitory at the Camden site, in a sum not to exceed\$102,055.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 19 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a dormitory at the Camden site, in a sum not to exceed\$5,000,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 19 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Arkansas Fire Training Academy Driving Course, in a sum not to exceed\$500,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 19 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$60,000.

SECTION 22. REAPPROPRIATION - SAU - TECH - ENVIRONMENTAL TRAINING ACADEMY. There is hereby appropriated, to the SAU - Tech, to be payable from the Development and Enhancement Fund, for the SAU - Tech the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 20 of Act 5 of 2020, for instructional equipment, in a sum not to exceed\$25,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 20 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$10,000.

SECTION 23. REAPPROPRIATION - UNIVERSITY OF ARKANSAS COMMUNITY COLLEGE AT BATESVILLE. There is hereby appropriated, to the University of Arkansas Community College at Batesville, to be payable from the Development and Enhancement Fund, for the University of Arkansas Community College at Batesville the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 22 of Act 5 of 2020, for upgrades, repair, and replacement of instructional equipment, in a sum not to exceed\$750,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 22 of Act 5 of 2020, for renovation of the Main Classroom Building, in a sum not to exceed\$850,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 22 of Act 5 of 2020, for maintenance and stabilization of the vehicular bridge near the center of campus, in a sum not to exceed\$500,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 22 of Act 5 of 2020, for land acquisition, in a sum not to exceed\$750,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 22 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$40,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 22 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$180,000.

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 23 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Texarkana Classroom Building, in a sum not to exceed\$1,745,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 23 of Act 5 of 2020, for upgrades and replacement of instructional technology, in a sum not to exceed\$420,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 23 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Testing Center, in a sum not to exceed\$685,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 23 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$20,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 23 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$260,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 23 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$155,920.

SECTION 25. REAPPROPRIATION - UNIVERSITY OF ARKANSAS COMMUNITY COLLEGE AT MORRILTON. There is hereby appropriated, to the University of Arkansas Community College at Morrilton, to be payable from the Development and Enhancement Fund, for the University of Arkansas Community College at Morrilton the following:

(A) Effective July 1, 2021, the balance of the appropriation provided

in Item (A) of Section 24 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of an Allied Health/Health Sciences Building, in a sum not to exceed\$1,500,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 24 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources to expand Technology Building III, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 24 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources to expand Technology Building II, in a sum not to exceed\$350,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 24 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$10,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 24 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$390,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 24 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$224,255.

SECTION 26. REAPPROPRIATION - UNIVERSITY OF ARKANSAS COMMUNITY COLLEGE AT RICH MOUNTAIN. There is hereby appropriated, to the University of Arkansas Community College at Rich Mountain, to be payable from the Development and Enhancement Fund, for the University of Arkansas Community College at Rich Mountain the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 25 of Act 5 of 2020, for technology upgrades and renovations of science labs, in a sum not to exceed\$620,500.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 25 of Act 5 of 2020, for technology upgrades and renovations of the lecture hall, in a sum not to exceed\$590,500.

(C) Effective July 1, 2021, the balance of the appropriation provided

in Item (D) of Section 25 of Act 5 of 2020, for clinical/instructional equipment for Allied Health Programs, in a sum not to exceed\$200,500.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 25 of Act 5 of 2020, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources for the Fine Arts Performance Center, in a sum not to exceed\$438,500.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 25 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$40,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (G) of Section 25 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$90,000.

(G) Effective July 1, 2021, the balance of the appropriation provided in Item (H) of Section 25 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$81,240.

SECTION 27. REAPPROPRIATION - UNIVERSITY OF ARKANSAS COMMUNITY COLLEGE AT RICH MOUNTAIN - MENA HISTORIC ARMORY. There is hereby appropriated, to the University of Arkansas Community College at Rich Mountain, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas Community College at Rich Mountain the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$237,000.

SECTION 28. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - PULASKI TECHNICAL COLLEGE. There is hereby appropriated, to the University of Arkansas - Pulaski Technical College, to be payable from the Development and Enhancement Fund, for the University of Arkansas - Pulaski Technical College the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 27 of Act 5 of 2020, for the sealing of windows and brick for the CCB, IT/BTC and Science Library Buildings, in a sum not to exceed\$330,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 27 of Act 5 of 2020, for parking lot maintenance for the Main and South campuses, in a sum not to exceed\$120,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 27 of Act 5 of 2020, for roof replacement and repair for the Administration Building, in a sum not to exceed\$200,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 27 of Act 5 of 2020, for critical maintenance, in a sum not to exceed\$60,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 27 of Act 5 of 2020, for deferred maintenance, in a sum not to exceed\$550,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 27 of Act 5 of 2020, for repair or replacement of equipment and library holdings, in a sum not to exceed\$622,055.

SECTION 29. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 30. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 31. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2021 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2021 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2021.
