HOUSE BILL 1082

For An Act To Be Entitled

AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
IMPROVEMENT APPROPRIATIONS FOR THE DEPARTMENT OF
HUMAN SERVICES - DIVISION OF DEVELOPMENTAL
DISABILITIES SERVICES; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE DEPARTMENT OF HUMAN
SERVICES - DIVISION OF DEVELOPMENTAL
DISABILITIES SERVICES REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - DEVELOPMENTAL DISABILITIES SERVICES.

There is hereby appropriated, to the Department of Human Services, to be payable from the federal funds as designated by the Chief Fiscal Officer of the State, for the Department of Human Services - Division of Developmental Disabilities Services the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 1 of Act 203 of 2021, for implementation of the Booneville Human Development Center master plan including costs associated with demolition, construction, replacement, renovation, upgrade, and addition of facilities at the Booneville Human Development Center, in a sum not to exceed\$1,184,925.

(B) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 1 of Act 203 of 2021, for implementation of the residential housing plan of the Booneville Human Development Center master plan including costs associated with demolition, construction, replacement,



renovation, upgrade, and addition of facilities at the Booneville Human Development Center, in a sum not to exceed\$7,819,000.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 1 of Act 869 of 2021, for continued implementation of the master plans at each Human Development Center including demolition, construction, replacement, upgrade, and addition of facilities, in a sum not to exceed\$15,000,000.

(D) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 1 of Act 869 of 2021, for costs associated with construction of five (5) living units for medically fragile residents as part of the master plan at the Conway Human Development Center, in a sum not to exceed\$12,000,000.

(E) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 1 of Act 869 of 2021, for construction of new medical facilities at the five (5) Human Development Centers in accordance with the master plans at each Human Development Center, in a sum not to exceed\$6,000,000.

SECTION 2. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided

otherwise by law.

SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 4. EFFECTIVE DATE. This act is effective on and after July 1, 2022.
