AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF
HIGHER EDUCATION; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER
EDUCATION REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO.

There is hereby appropriated, to the Arkansas State University, to be payable from the Development and Enhancement Fund, for the Arkansas State University the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 1 of Act 847 of 2021, for construction, renovation, maintenance, equipment, personal services and operating expenses of the various institutions and entities of the Arkansas State University System, in a sum not to exceed\$15,000,000.

(B) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 1 of Act 847 of 2021, for costs of construction of a College of Engineering building, in a sum not to exceed\$4,364,480.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 1 of Act 847 of 2021, for College of Education and Communications restrooms renovation, in a sum not to exceed\$908,500.

(D) Effective July 1, 2022, the balance of the appropriation provided in Item (D) of Section 1 of Act 847 of 2021, for Library HVAC system



renovation and modernization, in a sum not to exceed\$3,227,020.

(E) Effective July 1, 2022, the balance of the appropriation provided in Item (E) of Section 1 of Act 847 of 2021, for critical maintenance, in a sum not to exceed\$710,000.

(F) Effective July 1, 2022, the balance of the appropriation provided in Item (F) of Section 1 of Act 847 of 2021, for deferred maintenance, in a sum not to exceed\$2,870,000.

(G) Effective July 1, 2022, the balance of the appropriation provided in Item (G) of Section 1 of Act 847 of 2021, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$2,989,855.

(H) Effective July 1, 2022, the balance of the appropriation provided in Item (H) of Section 1 of Act 847 of 2021, for costs of implementing the ASU System Enterprise Resource Program, in a sum not to exceed ...\$1,250,000.

SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - COGSWELL PORTRAIT CONSERVATION. There is hereby appropriated, to the Arkansas State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas State University the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Section 24 of Act 832 of 2021, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed\$14,000.

SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - PFEIFFER-JANES HOUSE ROOF REPAIR. There is hereby appropriated, to the Arkansas State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas State University the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Section 24 of Act 832 of 2021, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed\$22,950.

SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO -

MITCHELL-EAST BUILDING WINDOW RESTORATION. There is hereby appropriated, to the Arkansas State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas State University the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Section 24 of Act 832 of 2021, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed\$59,500.

SECTION 5. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - SUSTAINABLE BUILDING DESIGN. There is hereby appropriated, to the Arkansas State University, to be payable from the Sustainable Building Design Revolving Loan Fund, for the Arkansas State University the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 3 of Act 181 of 2021, for construction, renovation, maintenance and operating expenses, in a sum not to exceed\$30,155.

SECTION 6. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY. There is hereby appropriated, to the Arkansas Tech University, to be payable from the Development and Enhancement Fund, for the Arkansas Tech University the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 2 of Act 847 of 2021, for McEver Science Building, Dean Hall, & Tucker Coliseum renovation, in a sum not to exceed ..\$4,765,200.

(B) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 2 of Act 847 of 2021, for costs of construction of 0 Street closure and Campus Entrance, in a sum not to exceed\$2,330,000.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 2 of Act 847 of 2021, for renovation for Brown building academic utilization, in a sum not to exceed\$1,180,438.

(D) Effective July 1, 2022, the balance of the appropriation provided in Item (D) of Section 2 of Act 847 of 2021, for technology infrastructure upgrades and improvements, in a sum not to exceed\$224,362.

(E) Effective July 1, 2022, the balance of the appropriation provided in Item (E) of Section 2 of Act 847 of 2021, for critical maintenance, in a sum not to exceed\$1,210,000.

(F) Effective July 1, 2022, the balance of the appropriation provided in Item (F) of Section 2 of Act 847 of 2021, for deferred maintenance, in a sum not to exceed\$3,780,000.

(G) Effective July 1, 2022, the balance of the appropriation provided in Item (G) of Section 2 of Act 847 of 2021, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$1,314,122.

(H) Effective July 1, 2022, the balance of the appropriation provided in Item (H) of Section 2 of Act 847 of 2021, for reroofing the Allied Health Building on the Ozark Campus, in a sum not to exceed\$142,212.

(I) Effective July 1, 2022, the balance of the appropriation provided in Item (I) of Section 2 of Act 847 of 2021, for costs of construction of a Technology Trade Center on the Ozark Campus, in a sum not to exceed\$1,357,788.

(J) Effective July 1, 2022, the balance of the appropriation provided in Item (J) of Section 2 of Act 847 of 2021, for critical maintenance for the Ozark Campus, in a sum not to exceed\$20,000.

(K) Effective July 1, 2022, the balance of the appropriation provided in Item (K) of Section 2 of Act 847 of 2021, for deferred maintenance for the Ozark Campus, in a sum not to exceed\$210,000.

SECTION 7. REAPPROPRIATION - HENDERSON STATE UNIVERSITY. There is hereby appropriated, to the Henderson State University, to be payable from the Development and Enhancement Fund, for the Henderson State University the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 3 of Act 847 of 2021, for technology infrastructure upgrades, in a sum not to exceed\$1,500,000.

(B) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 3 of Act 847 of 2021, for Reynolds Labs renovation, in a sum not to exceed\$850,000.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 3 of Act 847 of 2021, for roof replacement for the Library and Womack building, in a sum not to exceed\$795,000.

(D) Effective July 1, 2022, the balance of the appropriation provided in Item (D) of Section 3 of Act 847 of 2021, for renovation of the Russell

Fine Arts Building, in a sum not to exceed\$4,355,000.

(E) Effective July 1, 2022, the balance of the appropriation provided in Item (E) of Section 3 of Act 847 of 2021, for critical maintenance, in a sum not to exceed\$280,000.

(F) Effective July 1, 2022, the balance of the appropriation provided in Item (F) of Section 3 of Act 847 of 2021, for deferred maintenance, in a sum not to exceed\$1,900,000.

(G) Effective July 1, 2022, the balance of the appropriation provided in Item (G) of Section 3 of Act 847 of 2021, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$597,420.

SECTION 8. REAPPROPRIATION - HENDERSON STATE UNIVERSITY - CADDO CENTER PHASE V. There is hereby appropriated, to the Henderson State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Henderson State University the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Section 24 of Act 832 of 2021, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed\$1,190,861.

SECTION 9. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY. There is hereby appropriated, to the Southern Arkansas University, to be payable from the Development and Enhancement Fund, for the Southern Arkansas University the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 4 of Act 847 of 2021, for costs of HVAC replacement and upgrades, in a sum not to exceed\$3,783,000.

(B) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 4 of Act 847 of 2021, for technology infrastructure improvements and upgrades, in a sum not to exceed\$2,500,000.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 4 of Act 847 of 2021, for renovation of Childs Hall and ADA upgrades to create the Science, Technology, Engineering and Mathematics Training Center, in a sum not to exceed\$1,217,000.

(D) Effective July 1, 2022, the balance of the appropriation provided

in Item (D) of Section 4 of Act 847 of 2021, for critical maintenance, in a sum not to exceed\$520,000.

(E) Effective July 1, 2022, the balance of the appropriation provided in Item (E) of Section 4 of Act 847 of 2021, for deferred maintenance, in a sum not to exceed\$1,910,000.

(F) Effective July 1, 2022, the balance of the appropriation provided in Item (F) of Section 4 of Act 847 of 2021, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$712,642.

SECTION 10. REAPPROPRIATION - UNIVERSITY OF ARKANSAS FOR MEDICAL SCIENCES. There is hereby appropriated, to the University of Arkansas for Medical Sciences, to be payable from the Development and Enhancement Fund, for the University of Arkansas for Medical Sciences the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 5 of Act 847 of 2021, for renovation of the Barton Building, in a sum not to exceed\$2,500,000.

(B) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 5 of Act 847 of 2021, for renovation of the EDII 6th Floor for the College of Pharmacy, in a sum not to exceed\$2,000,000.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 5 of Act 847 of 2021, for renovation of the Monroe Building, in a sum not to exceed\$2,000,000.

(D) Effective July 1, 2022, the balance of the appropriation provided in Item (D) of Section 5 of Act 847 of 2021, for renovation of the Central Building - Floors 2-8, in a sum not to exceed\$2,000,000.

(E) Effective July 1, 2022, the balance of the appropriation provided in Item (E) of Section 5 of Act 847 of 2021, for critical maintenance, in a sum not to exceed\$7,080,000.

(F) Effective July 1, 2022, the balance of the appropriation provided in Item (F) of Section 5 of Act 847 of 2021, for deferred maintenance, in a sum not to exceed\$11,420,000.

(G) Effective July 1, 2022, the balance of the appropriation provided in Item (G) of Section 5 of Act 847 of 2021, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$1,918,925.

SECTION 11. REAPPROPRIATION - UNIVERSITY OF ARKANSAS. There is hereby appropriated, to the University of Arkansas, to be payable from the Development and Enhancement Fund, for the University of Arkansas the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 6 of Act 847 of 2021, for construction, renovation, maintenance, equipment, personal services and operating expenses of the various institutions and entities of the University of Arkansas System, in a sum not to exceed\$15,000,000.

(B) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 6 of Act 847 of 2021, for costs of construction of the Institute for Integrative and Innovative Research, in a sum not to exceed\$3,500,000.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 6 of Act 847 of 2021, for renovation and restoration of the Agriculture Building, in a sum not to exceed\$2,000,000.

(D) Effective July 1, 2022, the balance of the appropriation provided in Item (D) of Section 6 of Act 847 of 2021, for renovation and restoration of the John A. White, Jr. Engineering Hall, in a sum not to exceed\$2,000,000.

(E) Effective July 1, 2022, the balance of the appropriation provided in Item (E) of Section 6 of Act 847 of 2021, for renovation of the Business Building, in a sum not to exceed\$2,000,000.

(F) Effective July 1, 2022, the balance of the appropriation provided in Item (F) of Section 6 of Act 847 of 2021, for critical maintenance for the U of A - Fayetteville, in a sum not to exceed\$5,630,000.

(J) Effective July 1, 2022, the balance of the appropriation provided in Item (J) of Section 6 of Act 847 of 2021, for critical maintenance for the U of A - System, in a sum not to exceed\$10,000.

(K) Effective July 1, 2022, the balance of the appropriation provided in Item (K) of Section 6 of Act 847 of 2021, for deferred maintenance for the U of A - System, in a sum not to exceed\$50,000.

(L) Effective July 1, 2022, the balance of the appropriation provided in Item (L) of Section 6 of Act 847 of 2021, for upgrades and renovations to the Agricultural Research and Extension Centers and Stations of the Division of Agriculture, in a sum not to exceed\$3,500,000.

(M) Effective July 1, 2022, the balance of the appropriation provided in Item (M) of Section 6 of Act 847 of 2021, for costs of construction of the Northeast Rice Research & Extension Center, in a sum not to exceed\$1,000,000.

(A) Effective July 1, 2022, the balance of the appropriation provided in Section 24 of Act 832 of 2021, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed\$56,569.

SECTION 13. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - JOHN A. WHITE, JR. ENGINEERING HALL PHASE II. There is hereby appropriated, to the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Section 24 of Act 832 of 2021, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed\$950,000.

SECTION 14. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - GARVAN GARDENS WOODLANDS PARKWAY. There is hereby appropriated, to the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Section 24 of Act 832 of 2021, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed\$85,000.

SECTION 15. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FORT SMITH. There is hereby appropriated, to the University of Arkansas at Fort Smith, to be payable from the Development and Enhancement Fund, for the University of Arkansas at Fort Smith the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 7 of Act 847 of 2021, for costs of construction and renovation for the UAFS Center for Workforce Development, in a sum not to exceed\$6,522,500.

(B) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 7 of Act 847 of 2021, for critical maintenance, in a sum not to exceed\$550,000.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 7 of Act 847 of 2021, for deferred maintenance, in a sum not to exceed\$1,640,000.

(D) Effective July 1, 2022, the balance of the appropriation provided in Item (D) of Section 7 of Act 847 of 2021, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$704,055.

SECTION 16. REAPPROPRIATION - UNIVERSITY OF ARKANSAS AT LITTLE ROCK.

There is hereby appropriated, to the University of Arkansas at Little Rock, to be payable from the Development and Enhancement Fund, for the University of Arkansas at Little Rock the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 8 of Act 847 of 2021, for improvements to technology infrastructure, in a sum not to exceed\$4,000,000.

(B) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 8 of Act 847 of 2021, for classroom technology improvements, in a sum not to exceed\$264,527.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 8 of Act 847 of 2021, for construction costs to complete the Nanotechnology Center, in a sum not to exceed\$2,000,000.

(D) Effective July 1, 2022, the balance of the appropriation provided in Item (D) of Section 8 of Act 847 of 2021, for building infrastructure/critical maintenance, in a sum not to exceed\$2,735,473.

(E) Effective July 1, 2022, the balance of the appropriation provided in Item (E) of Section 8 of Act 847 of 2021, for critical maintenance, in a sum not to exceed\$6,470,000.

(F) Effective July 1, 2022, the balance of the appropriation provided in Item (F) of Section 8 of Act 847 of 2021, for deferred maintenance, in a sum not to exceed\$5,580,000.

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 21 of Act 181 of 2021, for construction, renovation, maintenance and operating expenses, in a sum not to exceed\$1,000,000.

SECTION 18. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - MONTICELLO.

There is hereby appropriated, to the University of Arkansas at Monticello, to be payable from the Development and Enhancement Fund, for the University of Arkansas at Monticello the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 9 of Act 847 of 2021, for costs of construction of a Math and Science Center, in a sum not to exceed\$4,750,000.

(B) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 9 of Act 847 of 2021, for renovation of the Fine Arts Center, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 9 of Act 847 of 2021, for renovation of the Music Building, in a sum not to exceed\$750,000.

(D) Effective July 1, 2022, the balance of the appropriation provided in Item (D) of Section 9 of Act 847 of 2021, for costs of construction of the Workforce/Collegiate Center on the Crossett campus, in a sum not to exceed\$1,500,000.

(E) Effective July 1, 2022, the balance of the appropriation provided in Item (E) of Section 9 of Act 847 of 2021, for costs of construction of a General Education Building on the McGehee campus, in a sum not to exceed\$1,500,000.

(G) Effective July 1, 2022, the balance of the appropriation provided in Item (G) of Section 9 of Act 847 of 2021, for deferred maintenance at the Crossett campus, in a sum not to exceed\$120,000.

(H) Effective July 1, 2022, the balance of the appropriation provided in Item (H) of Section 9 of Act 847 of 2021, for deferred maintenance at the McGehee campus, in a sum not to exceed\$150,000.

(I) Effective July 1, 2022, the balance of the appropriation provided in Item (I) of Section 9 of Act 847 of 2021, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$445,592.

SECTION 19. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - PINE BLUFF.

There is hereby appropriated, to the University of Arkansas at Pine Bluff, to be payable from the Development and Enhancement Fund, for the University of Arkansas at Pine Bluff the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 10 of Act 847 of 2021, for costs of construction of a Student Center, in a sum not to exceed\$3,000,000.

(B) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 10 of Act 847 of 2021, for costs of campus renovations and repair, in a sum not to exceed\$2,895,000.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 10 of Act 847 of 2021, for technology infrastructure upgrades, in a sum not to exceed\$605,000.

(D) Effective July 1, 2022, the balance of the appropriation provided in Item (D) of Section 10 of Act 847 of 2021, for critical maintenance, in a sum not to exceed\$490,000.

(E) Effective July 1, 2022, the balance of the appropriation provided in Item (E) of Section 10 of Act 847 of 2021, for deferred maintenance, in a sum not to exceed\$1,600,000.

(F) Effective July 1, 2022, the balance of the appropriation provided in Item (F) of Section 10 of Act 847 of 2021, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$383,776.

(G) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 23 of Act 181 of 2021, for matching funds for the 1890 Research and Extension Programs, in a sum not to exceed\$144,000.

(H) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 23 of Act 181 of 2021, for matching funds for the 1890 Research and Extension Programs, in a sum not to exceed\$700,000.

SECTION 20. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - PINE BLUFF - HAZZARD GYMNASIUM RENOVATION PHASE I. There is hereby appropriated, to the University of Arkansas at Pine Bluff, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas at Pine Bluff the following:

(A) Effective July 1, 2022, the balance of the appropriation provided

in Section 24 of Act 832 of 2021, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$2,100,000.

SECTION 21. REAPPROPRIATION - UNIVERSITY OF CENTRAL ARKANSAS. There is hereby appropriated, to the University of Central Arkansas, to be payable from the Development and Enhancement Fund, for the University of Central Arkansas the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 11 of Act 847 of 2021, for costs of construction for an addition to, renovation of, and equipment for the Lewis Science Center, in a sum not to exceed\$3,000,000.

(B) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 11 of Act 847 of 2021, for renovation of Mashburn Hall, in a sum not to exceed\$3,000,000.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 11 of Act 847 of 2021, for renovation of Old Main, in a sum not to exceed\$2,500,000.

(D) Effective July 1, 2022, the balance of the appropriation provided in Item (D) of Section 11 of Act 847 of 2021, for critical maintenance, in a sum not to exceed\$1,060,000.

(E) Effective July 1, 2022, the balance of the appropriation provided in Item (E) of Section 11 of Act 847 of 2021, for deferred maintenance, in a sum not to exceed\$3,820,000.

(F) Effective July 1, 2022, the balance of the appropriation provided in Item (F) of Section 11 of Act 847 of 2021, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$1,948,849.

SECTION 22. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State

Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 23. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 24. EFFECTIVE DATE. This act is effective on and after July 1, 2022.
